In Chapter 21.15: 21.15.3155- Urban Agricultural Use.

"Urban Agriculture use" means farming in all its branches including, but not limited to, the cultivation and tillage of the soil, the production, cultivation, growing, and harvesting of any agricultural or horticultural products, the raising of livestock, bees, furbearing animals, dairy-producing animals, and poultry, agricultural education, the sale of produce through field retail stands or farms stands, and any practices performed by a farmer or on a farm as an incident to or in conjunction with farming operations. For purposes of this definition, the term "urban agricultural use" does not include timber production and does not include cultivation of marijuana.
