THIRD AMENDMENT TO AGREEMENT NO. 33431

THIS THIRD AMENDMENT TO AGREEMENT NO. 33431 is made and entered, in duplicate, as of March 15, 2017 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on March 18, 2014, by and between ONWARD ENGINEERING, a California corporation, with a place of business at 300 S. Harbor Blvd., Suite 814, Anaheim, California 92805 ("Consultant"), and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with on-call street design consulting services; and

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 33431 (the "Agreement') whereby Consultant agreed to provide these services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to update the schedule of rates charged by Consultant; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to update the City representative and extend the term an additional one (1) year period; and

WHEREAS, the Parties desire to decrease the Agreement by \$200,000 for a total not to exceed amount of \$800,000;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the parties agree as follows:

- 1. Section 1.A of the Agreement is hereby amended to read as follows.
- "A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, not to exceed Eight Hundred Thousand Dollars (\$800,000), at the rates or charges shown in Exhibit "B"."
 - 2. Except as expressly modified herein, all of the terms and conditions
