CONTRACT

THIS CONTRACT ("Contract") is made and entered, in duplicate, as of July 19, 2017, for reference purposes only, pursuant to Resolution No. RES-17-0068, adopted by the City Council of the City of Long Beach at its meeting on July 18, 2017, by and between XL HYBRIDS, INC., a Delaware corporation ("Contractor"), with a place of business at 145 Newton Street, Boston, MA 02135, and the CITY OF LONG BEACH ("City"), a municipal corporation.

WHEREAS, the City has a total of eleven (11) Ford Transit vans and eight (8) Ford F-150 trucks ("UNITS") used by the Public Works and other City departments that are part of a pilot program for the City to support operational use testing for suitability and actual fuel savings; and

WHEREAS, these 19 UNITS need to be converted to gasoline hybrid and plug-in hybrid electric units; and

WHEREAS, XL HYBRIDS, INC. is the only vendor certified by the Ford Motor Company to perform these vehicle conversions; and

WHEREAS, City did by Resolution No. RES-17-0068 determine that the City's need to convert these UNITS could only be met by Contractor and, by reason of the foregoing, no useful purpose would be served by advertising for bids, and to do so would constitute an idle and useless act and an unnecessary expenditure of public funds; and

NOW, THEREFORE, in consideration of the mutual terms and conditions contained herein, the parties agree as follows:

- Contractor shall perform these vehicle conversions, as authorized by Resolution No. RES-17-0068 and described in Exhibit "A" attached to this Contract and incorporated by this reference.
- 2. City shall pay Contractor in due course of payments, following receipt of an invoice from Contractor and upon acceptance from City, for the vehicle

- 3. The term of this Contract shall be deemed to have commenced on July 18, 2017, and shall terminate at midnight on July 17, 2018, unless sooner terminated as provided in this Contract.
- 4. The City may terminate this Contract by giving thirty (30) days prior notice of termination to Contractor.
- 5. Neither this Contract nor any of the moneys that may become due Contractor hereunder may be assigned without the prior written consent of City.
- 6. Any notices required hereunder or desired to be given by either party shall be in writing and personally delivered or deposited in the U.S. Postal Service, first class postage prepaid, addressed to Contractor at the address stated herein, and to City at 333 West Ocean Boulevard, Long Beach, California 90802 Attn: City Manager. Notice shall be deemed given on the date personal delivery is made or on the date of deposit in the mail, whichever first occurs.
- 7. City shall have the benefit of any warranty from the manufacturer on the vehicle conversions, and Contractor warrants that the vehicle conversion parts are in good working order and free from defect at the time of delivery.
- 8. Contractor must maintain certification from the Ford Motor Company as qualified vehicle modifier during the term of this agreement.
