BACKGROUND:

Utopia Good Food & Fine Art is an eat-in restaurant, specializing in lunch, dinner and weekend leisure dining with outdoor patio seating, monthly art showings and live music on weekends established in 1999. Utopia Good Food and Fine Art is located in downtown's East Village. It is an oasis and gathering place where busy people can find a casual, comfortable and creative environment. Utopia's good food feeds your body. Its' fine art feeds your soul. Utopia Good Food and Fine Art is fully committed to engage our customers with renewed energy, an enhanced personal standard of service, and a menu that reflects our cultural diversity. The restaurant has enjoyed the overwhelming support of the artist, gay & lesbian community, as well as deep loyalty from countless neighborhood customers.

The loan request is working capital to support the purchase of a full liquor license and the required permitting associated with it. Currently, the restaurant features beer and wine only, but has been working with a business broker to acquire an ABC Type 47 license, and has already made a deposit of \$13,000 towards the purchase. In addition, the owners plan to use \$140,000 in accumulated assets and equity to renovate the existing bar area and open up the restaurant space surrounding the current bar to include 360 degrees of bar access and seating. The renovation project will be completed with equity shown on the Balance Sheet currently invested in a Charles Schwab account. This project is estimated to be completed in 2018 and acquiring the liquor license will happen simultaneously as architectural plans and permits are prepared for city approval. The added amenities are estimated to increase current sales by at least 20%.

Amir Zolghadr is the co-owner and has more than 30 years of experience in the restaurant industry. He manages the daily operations of the company, as well as provides valuable quality control on all prepared items to ensure highest standards are met with consistency and the utmost customer service.

Kamran Assadi is the co-owner and a restaurateur with more than 25 years of experience in organizing and managing services in the food and beverage industry with proven leadership & managerial abilities. He has excellent communication and interpersonal skills & is also highly skilled at problem identification/problem resolution. His results-oriented and hands-on experience in managing restaurant functions ensures exceptional customer service. He is a graduate of California State University Long Beach, department of Fine Art.
