


# Amazon's Request for Proposal

- September 7, 2017: Amazon announces search for second headquarters (HQ2)
- Long Beach is part of (MSA) Metropolitan
   Statistical Area of Los Angeles/ Long Beach/
   Anaheim allow to submit responses in Los Angeles
   and Orange County
- Amazon's RFP core requirements
  - Metropolitan areas with a population of over
     1 million
  - o A stable and business-friendly environment
  - o Within 30 miles of a population center
  - Within 45 minutes to an international airport
  - Proximity to major highways and arterial roads 1–3 miles
  - Access to mass transit routes
  - Up to 8 million square feet of office space for future expansion



### City Response

- The City Council of Long Beach tasked the Economic Development Department to create a "Red Team" to respond to Amazon's HQ2 RFP
- Approved by the entire City Council on September 12, 2017, upon request from Councilwoman Gonzalez, Councilmember Supernaw and Councilwoman Mungo
- City staff asked to work all City departments,
   County & State Agencies, and other partners to respond to the RFP



# Creative partnerships to meet requirements

With a preference for a metropolitan population of 1 million, City of Long Beach submitted two proposals

## LAEDC: Project Constellation

The proposal contains nine separate and distinct locations throughout Los Angeles County, including City of Long Beach

These locations include (but are not limited to)

- City of Long Beach
- City of Los Angeles
- City of Pomona
- City of Woodland Hills
- City of Santa Clarita

The purpose of this combined bid affords Amazon a strong set of options including existing collections of buildings, in-fill development opportunities and vacant sites

- Deadline for final RFP submission: October 19, 2017
- Amazon received 238 proposals
- If Amazon selects a proposal, it will announce it's site selection in 2018. Amazon has stated that this RFP is only an invitation for proposals, the substance of which may be memorialized in a binding, definitive agreement or agreements if any proposal is selected. Amazon may select one or more proposals and negotiate with the parties submitting such proposals before making an award decision, or it may select no proposals and enter into no agreement
- Prior to Amazon's announcement of site selections(s), it has been determined that disclosure of the proposal details may adversely affect the City of Long Beach's competitive chance of winning Amazon's second headquarters
- No commitments have been made regarding the properties included in the proposal for the City of Long Beach
