FIRST AMENDMENT TO AFTER-SCHOOL PROGRAM SERVICES AGREEMENT

THIS AMENDMENT to AGREEMENT is made 9/22/2017, between CITY OF LONG BEACH DEPARTMENT OF PARKS, RECREATION AND MARINE, hereinafter referred to as CONTRACTOR, and the LONG BEACH UNIFIED SCHOOL DISTRICT, hereinafter referred to as DISTRICT.

WITNESSETH

The CONTRACTOR and DISTRICT do mutually agree as follows:

- 1. To amend that certain AGREEMENT 1718-0034-00 approved by the Board of Education on 6/20/2017 to operate the after-school program at Hudson K-8 School. Please amend the AGREEMENT to include the following:
 - A. By updating the address and telephone number of the WRAP Office from Tucker Administrative Office, 2221 Argonne Avenue, Long Beach, CA, 90815, Telephone 562-498-2324 to their new office location at 4400 Ladoga Avenue, Lakewood, CA 90713, Telephone 562-997-8000 Extension 7172; and
 - B. By increasing the rates from \$6.375 per student attendance for the Core Program and three-hour Supplemental Program, and \$12.75 per student attendance for the six-hour Supplemental Program to \$6.96 per student attendance for the Core Program and three-hour Supplemental Program, and \$13.92 per student attendance for the six-hour Supplemental Program; and
 - C. By increasing the AGREEMENT amount by \$16,466 from \$178,968, for a total not-to-exceed amount of \$195,434. Revised maximum program costs are as follows: \$162,018 Core Program and \$33,416 Supplemental Program.
- 2. Where any Article or portion is amended or superseded, the balance of that Article not specifically amended or superseded shall remain in effect as originally written. Where any Article or portion thereof is supplemented, that supplement shall be considered added thereto, and the original provisions of the Article shall remain in effect as originally written. Where any Paragraph or Section is referenced, such Paragraph or Section is superseded and replaced by the language herein. Except as amended herein, the terms and conditions of AGREEMENT 1718-0034-00, shall remain in full force and effect.
