3 THIS FIRST AMENDMENT TO AGREEMENT NO. 33924 is made and
4 entered, in duplicate, as of October 31, 2017 for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on April
6 7, 2015, by and between WESTGROUP DESIGNS, INC., a California corporation
7 ("Consultant"), with a place of business at 19520 Jamboree Road, Suite 100, Irvine,
8 California 92612, and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City requires specialized services requiring unique skills to be
10 performed in connection with space planning consulting services; and

11 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.
12 33924 (the "Agreement") whereby Consultant agreed to provide these services; and

13 WHEREAS, the Parties desire to extend the term an additional one-year
14 period;

15 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
16 conditions herein contained, the Parties agree as follows:

17 1. Section 2 of the Agreement is hereby amended to read as follows:

18 "2. TERM. The term of this Agreement shall commence at midnight on
19 April 1, 2015, and shall terminate at 11:59 p.m. on March 31, 2019, unless sooner
20 terminated as provided in this Agreement, or unless the services or the Project is
21 completed sooner."

22 2. Except as expressly modified herein, all of the terms and conditions
23 contained in Agreement No. 33924 are ratified and confirmed and shall remain in full force
24 and effect.
