## FOURTH AMENDMENT TO CONTRACT NO. 33610 33610

THIS FOURTH AMENDMENT TO CONTRACT NO. 33610 is made and entered, in duplicate, as of November 15, 2017, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting held on November 14, 2017, by and between HAAKER EQUIPMENT COMPANY, a California corporation ("Contractor"), whose address is 2070 N. White Avenue, La Verne, California 91750, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, the parties entered into Contract No. 33610 whereby Contractor agreed to provide Elgin Pelican street sweeper parts; and

WHEREAS, the parties desire to increase the annual contract amount by \$150,000 for a total annual amount not to exceed \$400,000 for the contract period ending October 31, 2017 and increase the contract by \$250,000 for a total annual amount of \$500,000 for last remaining contract period from November 1, 2017 to October 31, 2018, for a revised total aggregate contract amount not to exceed \$1,500,000;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the parties agree as follows:

- 1. Section 2 of Contract No. 33610 is hereby amended to read as follows:
- "2. City shall pay Contractor in due course of payments, following receipt of an invoice from Contractor and upon acceptance from City for the street sweeper parts the prices shown in Exhibit "A", an annual amount not to exceed Four Hundred Thousand Dollars (\$400,000) for the contract period ending October 31, 2017 and an annual amount of Five Hundred Thousand Dollars (\$500,000) for last remaining contract period from November 1, 2017 to October 31, 2018, for a revised total aggregate contract amount not to exceed \$1,500,000, including tax."
- Except as expressly modified herein, all of the terms and conditions contained in Contract No. 33610 are ratified and confirmed and shall remain in full force
