**RECOMMENDED ACTION:**

**Respectfully request City Council approval of the 2018 State Legislative Agenda as recommended by the State Legislation Committee.**

**DISCUSSION**

Each year the City Council adopts a State Legislative Agenda, which outlines the City's State legislative priorities for the coming year. This document provides policy direction to staff on State legislative issues, and allows the City to support, oppose or work with State elected officials on advancing priorities adopted by the City Council.

At the State Legislation Committee meeting on November 21, 2017, the Committee voted to forward staff's recommended changes for the 2018 State Legislative Agenda, along with 26 additional changes from the Committee to the City Council for consideration and adoption. The Committee's proposed changes are described below:

**Economic Development**  
**City Council Directives**

**1. Grow and Strengthen our established industry clusters and emerging sectors.**

Amend Item (e) by eliminating reference to Transient Occupancy Tax as the measure by which tourism is evaluated. Item (e) shall read "Support policies, legislation, and grants to increase tourism activity."

Strike Item (l), previously Item (i), "Support legislation that minimizes wage discrepancies between tipped and untipped workers in the restaurant industry without impacting existing scheduled minimum wage increases."

**2. Increase access to economic opportunities in low-income communities to advance economic equity.**

Amend Objective 2 to read "Increase access to economic opportunities in all communities to advance economic opportunity holistically."

Amend item (c) by replacing the term "low-income" with "underserved" so that the language reads: "Support policies, legislation, and grants to increase

investment in all business corridors with prioritization for underserved business corridors."

Amend item (f) by replacing the term "low-income" with "underserved" so that the language reads: "Support policies, legislation and grants to decrease the digital divide for underserved community households."

Add new item (i) "Support policies, legislation, and grants that would ensure language access across all government documents for cultural competency."

**3. Ensure the preparedness of the workforce and competitiveness of business through alignment of economic development, training, education, and community partner efforts.**

Amend item (d) to include post-secondary education or certificate programs so that it reads "Support policies and legislation to increase the share of adult population with a Bachelor's degree, post-secondary education, or completion of certified certificate programs."

Add new item (j) "Support policies, legislation, and grants that assist the City in providing job training, community programming, with a focus on at-risk youth and reentry populations, as well as long term unemployed residents both to receive training and reenter the workforce."

**4. Build a supportive economic ecosystem that creates reliable pathways for entrepreneurs to confidently start and grow successful businesses.**

Amend item (c) to "Support policies and legislation to increase availability and access to high-speed internet."

Add new Item (c) in context with amendments to Item (d), which speak to establishing Long Beach as the most business friendly city in the world. The Committee's addition of a new Item (c), which reads: "Support policies, legislation and grant to establish Long Beach as one of the most worker friendly cities in the world", is intended to ensure that Long Beach does not seek to become the most business friendly city in the world at the expense of workers.

Amend item (d) to delete reference to becoming "one of the most business friendly cities in the State". The Committee seeks to "Support policies, legislation, and grants to establish Long Beach as the most business friendly city in the world."

Un-strike and amend item (h) to remove references to enabling immigrant communities to have access to driver's licenses, and maintain language to: "Support legislation and pursue pilot programs funding that expands workforce opportunities for immigrant communities in particular those that may utilize

recent State measures related to undocumented youth and other measures that have sought to remove barriers toward self-sufficiency.”

Amend Item (i) to emphasize local control and incentives with respect to partnerships with entities doing business at the Port of Long Beach to advance air quality goals so that the item now reads: “Support legislation that allows cities and/or jurisdictions to incentivize or collect fees from users of the goods movement system and from parties that impact local air quality and the environment.”

**5. Support workforce development activities that align with industry needs.**

Amend item (c) to “Support state incentives that increase the marketability of unemployed or under-employed workers by supporting policies, legislation, and grants that assist employees in receiving training in emerging industries to maintain competitive employment.”

**6. Enhance our quality of life to grow businesses, jobs, and investment that support a thriving local economy.**

Add new Item (g) to correspond with Objective 5, Item (d) to read: “Support green business initiatives and pursuing green business certification as a city.”

**Public Safety**

**City Council Directives**

**2. Ensure that Long Beach residents live in safe families and communities, attend safe schools, and are contributing citizens connected to their communities.**

With the passage of Proposition 64, which legalized adult-use marijuana, the Committee recommends amending Item (e) to remove mention of “medical” as the only aspect of marijuana regulations to monitor. Additionally, the Committee proposes to include language to support State advancements towards banking on behalf of cannabis as this is a safety issue. Item (e) reads: “Support State legislation that further clarifies marijuana laws in order to enable clear local enforcement of State law and advancements towards banking on behalf of cannabis.”

With State and local governments moving forward with regulations to enable medical and adult-use marijuana in certain areas of California, the Committee recommends striking Item (f), which currently reads: “Support policies and legislation to classify medical marijuana as a recognized pharmaceutical medication dispensed through pharmacies.”

Amend Item (l) by replacing “recreational marijuana” with the term “adult-use” so that the item now reads: “Support legislation that would strictly regulate the distribution of adult-use marijuana to enable clear local law enforcement vacancies.”

Amend Item (m) to include facilitating out-of-State law enforcement hires so that the item now reads: "Support legislation, policies, and grants that would facilitate lateral hiring of police officers both in state and out of state to fill critical law enforcement vacancies while maintaining high standards of cultural sensitivity, performance, and values."

Add new Item (o) "Support legislation, policies and grants that establish restorative justice programs in juvenile and adult courts."

**4. Embrace technology to enhance public safety services.**

Add new item (g) "Monitor legislation as it relates to crypto currency or bitcoin regulation specific to businesses and support policies, legislation and grants that tackle cyber security crimes."

**Education**

***City Council Directives***

**5. Support efforts to utilize technology and libraries.**

Add new Item (d) to "Support policies, legislation, and grants that incentivize community partnerships with local educational institutions to utilize shared space, equipment, and playgrounds."

**Sustainable and Livable Cities**

***City Council Directives***

**2. Support efforts to improve air quality.**

Add new item (j) "Support policies and legislation that seeks to ban non-recyclable and non-polystyrene materials from the waste stream."

**4. Support affordable housing policies consistent with the City's adopted housing policies.**

Amend item (a) to specifically state the City's interest in support for affordable housing funds that can be used in the City, as opposed to simply support for funding that would not necessarily benefit Long Beach so that the item now reads: "Support policies, legislation and grants that increases funding for affordable housing when equitable to Long Beach."

**5. Support energy resiliency.**

Add new item (h) "Support policies, legislation, and grants that continue the option for local governments to enter into Community Choice Aggregates agreements."

Amend item (c) to strengthen support for residents with disabilities so that the item now reads: "Support policies, legislation that provide sufficient process for business and other governmental entities to implement ADA requirements and to fully support residents with disabilities."

**6. Support public health programs and services.**

Amend Item (g) by changing Sexually Transmitted Diseases (STDs) to Sexually Transmitted Infections (STIs) so that the item now reads: "Support policies, legislation, and grants that promote and fund screening of communicable diseases, Sexually Transmitted Infections (STIs), and other emerging vector borne diseases in California."

**Subject:** Proposed Changes for the 2018 State Legislative Agenda

---

**Introduction**

Each year, City staff reviews the State Legislative Agenda and recommends changes to ensure the agenda is up-to-date and addresses the legislative concerns of the City. The 2017 agenda was sent to all departments for input. Attached for your review are staff's proposed changes.

**Proposed Legislative Agenda Changes**

**ECONOMIC DEVELOPMENT**

In 2017, the Long Beach City Council adopted the City's Economic Development Blueprint on April 4. This crucial document highlights seven key economic development objectives for the City, each of which can be met by supporting goals identified by the City's Economic Development Commission.

Staff recommends aligning the City's 2018 State Legislative Agenda with the first four key areas in the City's Economic Development Blueprint, while maintaining unique State Legislative City Council Directives adopted in years past.

**Objectives**

Previous State legislative Economic Development objectives included:

1. Cultivate a healthy environment to support sustainable economic growth.
2. Support community oriented businesses.
3. Support arts, tourism and culture.
4. Promote diversity, inclusiveness, and equity.
5. Support workforce development activities that align with industry needs.

Staff is proposing to replace the above objectives with the following adopted Economic Development Blueprint objectives:

1. Grow and strengthen our established industry clusters and emerging sectors.
2. Increase access to economic opportunities in low-income communities to advance economic equity.
3. Ensure the preparedness of the workforce and the competitiveness of business through alignment of economic development, training, education and community partner efforts.
4. Build a supportive economic ecosystem that creates reliable pathways for entrepreneurs to confidently start and grow successful businesses.

### Focus Statements

Staff proposes to amend the second Focus Statement to be specific to funds owed to the City of Long Beach, related to the dissolution of redevelopment.

Staff also proposes to amend the third Focus Statement to seek opportunities for leveraging private investments to benefit local communities.

### Council Directives

As mentioned, staff proposes to align the State Legislative Agenda with language from the City's adopted Economic Development Blueprint, and has included language from the Economic Development Blueprint, accordingly. Where the nature of statements is duplicative, staff proposes to use language from the Economic Development Blueprint, and remove the older language from previous State legislative agendas. Staff proposes to retain existing State Legislative Agenda statements that are not captured by the Economic Development Blueprint. All changes are shown in the attachment herein.

## **PUBLIC SAFETY**

### Objectives

Staff proposes to bring language pertaining to safe families, community participation in the public safety process, and technology higher up on the list of objectives since these are hallmarks of work that is being done by the City's Health and Human Services Department, in coordination with various City departments to improve public safety and wellness in Long Beach.

### Focus Statements

Realignment is expected to be a topic of State legislative discussion in 2018. Following the shooting and death of a Whittier Police Officer in 2017, the City of Whittier joined the City of Monrovia in leading regional discussions on realignment and its impact on local governments. City staff, through law enforcement groups and the Gateway Council of Governments have been participating in these educational conversations.

As implementation of Statewide and local medical marijuana laws begin to take shape, there will be lessons learned and potential opportunities for improvement to new systems and operations.

The fourth focus statement is amended to include mental health in recognition of the County of Los Angeles' efforts to find a lawful way to expand the role of social workers and law enforcement officers in detaining people with severe mental illness who refuse treatment through the definition of "grave disability". Currently state law defines "grave disability" as a condition in which a person, as a result of a mental disorder, is unable to provide for his or her basic personal needs (i.e. food, clothing, or shelter). The County is seeking to explore legislation that would include a person's inability to provide urgently needed medical care for him or herself due to a

mental disorder as part of grave disability. The need for this consideration derives from circumstances when an individual is in dire need of health and/or mental health care to the point their lives are in jeopardy, yet they refuse care due to lack of self-awareness to their own condition and need for treatment. These extreme circumstances should be explored and considered within state law to ensure that those in the gravest situations have access to life saving treatment.

#### City Council Directives

##### *Objective 1. Protect civil liberties, life, limb and property*

Staff proposes to add Item J to support legislation, policies and grants that would enable public health providers and partner agencies to provide treatment to mentally ill individuals who are unable to provide urgently needed medical care for him or herself due to a mental disorder as part of grave disability. This item is consistent with recent action by the Los Angeles County Board of Supervisors.

Staff also proposes to add Item K to support policies and legislation that protects Customer Proprietary Network Information (CPNI) by prohibiting broadband Internet access service providers from using, disclosing, or permitting access to individually identifiable personal information. This type of legislation represents an effort to reinstate the consumer privacy protections afforded by rules finalized by the Federal Communications Commission (FCC) in October 2016, but eliminated in 2017.

##### *Objective 2. Ensure that Long Beach Residents live in safe families and communities, attend safe schools, and are contributing citizens connected to their communities*

Staff proposes to add Item N to support legislation, policies and grants that fund prevention strategies that consider health, violence, trauma and other social determinants of health. Data has shown that trauma informed care, and awareness of the social determinants of health are important to building safe communities. Social determinants of health include: poverty, unemployment, income, education, and open space per acre.

##### *Objective 3. Encourage community participation in the public safety process by being open, transparent, and accessible to a diverse population*

Staff proposes to add Item D to support legislation that would encourage law enforcement agencies and academia to partner on research to benefit juvenile diversion programs and educational attainment.

Additionally, per City Council direction on September 19, 2017, staff proposes to add Item C to support policies, legislation and grants that would provide immigrant populations with due process protections, including legal representation for individuals facing deportation proceedings. The addition of this language is consistent with recent changes to the County of Los Angeles' State Legislative Agenda.

##### *Objective 4. Embrace technology to enhance public safety services*



Staff proposes to add Item D to support legislation, policies and grants that enable local law enforcement agencies to establish an interoperable database for ammunition and cartridge case documentation, including fingerprints found on ammunition and cartridge cases at documented crime scenes.

*Objective 5. Foster a healthy economic environment through law enforcement*

Staff proposes to amend Item C to support policies and legislation to make State law enforcement grant funding less restrictive and allow greater discretionary use of funds for support staff within the jail, data management and technology functions.

## **EDUCATION**

### Objectives

Staff has no proposed changes.

### Focus Statements

To streamline the Education section of the agenda, staff proposes to combine Objectives 1 and 4 to read: "Support quality education and education equity".

### City Council Directives

Consistent with staff's proposal to combine Objectives 1 and 4 to support quality education and educational equity, all existing City Council directives from Objective 4 will be moved up to join those in Objective 1.

## **SUSTAINABLE & LIVABLE CITIES**

### Objectives

Staff proposes to amend Objective 2 to include "stormwater management", as these activities support improvements with recreational water quality, but may also be stand alone efforts with other ancillary benefits, such as capture and reuse.

Staff proposes to amend Objective 4 to support affordable housing policies consistent with the City's adopted Housing Element.

Staff proposes to combine Objectives 7 and 8 to support parks, recreation and marine programming and infrastructure, which would also include support for animal care services.

### Focus Statements

Staff proposes to revise the second focus statement to support State policies, programs and initiatives consistent with the City's adopted Land Use Element, which considers a wide range of planning documents approved by the City Council.

With the passage of SB 1, which raises taxes and fees on transportation related items in 2017, staff proposes to remove the fourth bullet point, which focused on

support for transportation efforts that provide funding to cities for sustainable mobility programs, integrated connectivity projects, and zero-to-near zero emission vehicle development.

Staff proposes to add a statement regarding the City's support for the use of an equity lens in policy and program design, and funding to increase access and opportunity for all members of the Long Beach community.

In recognition of a shift to more sustainable transportation options, staff proposes to replace the fifth focus statement with support for policies that increase access to green or low-carbon transportation options.

#### City Council Directives

##### *Objective 1. Support efforts to improve air quality*

Staff proposes to amend Item B by deleting language related to AB 32 and SB 375, as these bills have been superseded by subsequent legislation. Authorization for California's Cap and Trade Program through AB 32 was only explicitly valid through the year 2020. In anticipation of that date, State Legislature adopted SB 32 in 2016 to extend the program through 2030; SB 32 also established emissions reductions targets of 40% below 1990 levels by 2030.

##### *Objective 2. Support efforts to improve stormwater management, and recreational water quality*

Amend Item A to include support for funding that would help the City meet municipal separate storm sewer systems (MS4) permit compliance costs. MS4 costs have risen significantly in recent years as new data demonstrates the extent to which cities need to mitigate stormwater pollution to improve recreational water quality and support healthy ecosystems.

##### *Objective 4. Support affordable housing policies consistent with the City's adopted Housing Element*

Staff proposes to add Item A to support policies, legislation and grants that increase funding for affordable housing.

Staff also proposes to amend Item B to include "substance abuse" as a category for which funding is needed to reduce homelessness.

*Objective 7. Support parks, recreation and marine programming and infrastructure*  
Consistent with staff's proposal to combine Objectives 7 and 8, all existing City Council Directives related to support for animal care services have been moved under this combined section.

## **LOCAL CONTROL**

### Objectives

Staff has no proposed changes.

**Focus Statements**

The first focus statement is amended to highlight the importance of focusing on community wellness at the neighborhood level since Long Beach has many neighborhoods, each with their unique needs.

The second focus statement is amended to support for implementing all City Council adopted planning documents.

**City Council Directives**

Staff has no proposed changes.

**Next Steps**

A State Legislation Committee meeting has been scheduled for November 21, 2017 at 4:30 PM to review and discuss staff's recommended changes for the 2018 State Legislative Agenda. City Council discussion and approval of the Committee's recommendations is expected to take place after the Committee takes action.

### About Long Beach

Incorporated in 1888, Long Beach, California is a progressive urban city made up of 464,000 residents and businesses. The City is home to the 2<sup>nd</sup> busiest port in the nation, a rejuvenated downtown, tourist attractions, one unified school district, a city college with two campuses, a state university, over 60 residential neighborhoods, 17 historical districts, and over 180 local neighborhoods and business organizations.

Long Beach is the 7<sup>th</sup> largest city in California, and the 2<sup>nd</sup> largest in Los Angeles County. The U.S. Census (2010) found that the median age in Long Beach is 33 years old, and 25% of the City's residents are under the age of 18.

*The City is ethnically diverse with: 40.8% Latino/Hispanic, 29.4% Caucasian, 13.0% African American, 12.6% Asian, and 1.1% Native Hawaiian and other Pacific Islander.*

The Los Angeles-Long Beach-Santa Ana area ranked #2 in the nation for having the greatest number of Lesbian, Gay or Bisexual persons. Long Beach was one of only 25 cities nationwide to achieve a perfect score on the Human Rights Campaign's Municipal Equality Index.

Long Beach Unified School District has 82,000 students spread over 84 schools. There are five charter schools and more than 40 private schools in Long Beach. Across the school district, 80% of high school students graduate on time. Long Beach City College and the California State University, Long Beach serve as local education hubs.

The City's economy is expanding as the region's economic base continues to shift from manufacturing to an information-based economy. There are several hundred businesses in the City. The top 10 private sector employers include Verizon and Boeing. The Port of Long Beach promises job growth and new career opportunities with the development of Long Beach Container Terminal's Middle Harbor and the Gerald Desmond Bridge Replacement.

*Located at the Port of Long Beach, Middle Harbor will be the world's 1st zero emissions terminal. An investment of over \$4 billion will be made into the regional economy over 40 years.*

Groundbreaking new programs and technologies are used in Long Beach to provide city services. The Long Beach Police Department has assembled the LB COP system using grant funds to integrate technologies to make this City a safer place to do business, live, work and play. The Long Beach Public Library has 12 branches with over 1.2 million visitors and 1.3 million materials loaned annually, and the City's Parks, Recreation and Marine Department has won the National Gold Medal Award 5 years in a row for providing quality programming and open space at over 170 locations throughout Long Beach.

- a)b) Support policies, legislation and grants to reduce homelessness, including housing assistance and case management service funding, including those related to mental health and, substance abuse, and as well as support efforts to ensure each city within the region is providing appropriate homeless accommodations.
- b)c) Support policies, legislation and grants that provides funding for enhanced services, such as facilities, senior housing, housing for the disabled, social services, mental health services, health care, supportive care, recreational programs and transportation to address the diverse needs of Long Beach's senior community.
- e)d) Support policies, legislation and grants that will help stabilize California's housing market for the consumer, by providing assistance to homeowners regarding reworking their mortgages, funding to combat the negative impacts of vacant residential foreclosed properties on local communities, and reforms that include establishing basic standards for fairness and transparency in the mortgage process, foreclosure proceedings, and tenant protections after foreclosures.

# LONG BEACH: LOCAL CONTROL

## City Council Directives

### **1. Oppose legislation that preempts the City's existing control over local matters**

- a) Support policies and legislation that protect and/or expands the City's authority and rights over its affairs.
- b) Oppose policies and legislation that preempt the current authority possessed by the City and delegates that authority to the State or other governmental jurisdiction.
- c) Support policies and legislation that requires that new safety regulations are made available for review and comment by employers prior to implementation.
- d) Support policies and legislation to reform workers' compensation statutes to simplify the system and reduce costs to employers, while ensuring adequate protection for injured workers.
- e) Support policies and legislation that provide more local government control over the regulation of sober-living homes that rent up to six beds and are not currently required to register for city business licenses, obtain conditional use permits or state licenses.
- f) Oppose policies and legislation that diminish the City's local control over land use, planning, zoning and development decisions, and oppose legislation in conflict with the City's adopted General Plan or other Council adopted land use policies.
- g) Support legislation that allows for local control of shopping cart retrieval.
- h) Support policies and legislation that provide more local government control on the regulation of drug and alcohol recovery facilities.
- i) Support legislation to reduce blight in neighborhoods by placing reasonable restrictions on utilizing vehicles solely for the purpose of advertisement.
- j) Support policies and legislation that would grant discretion to local government Traffic Engineers to make the final determination of a safe and reasonable speed limit.
- k) Oppose policies and legislation that restrict the use of local housing funds.
- l) Support or sponsor legislation to extend the authority of the Long Beach Oversight Board of the City of Long Beach as the Successor Agency to the Redevelopment Agency of the City of Long Beach.

- r) Support policies and legislation that enable cities to maximize their ability to efficiently administer local elections.
- s) Support legislation or a constitutional amendment that would stipulate that the expenditure of corporate money to influence the electoral process is not a form of constitutionally protected speech.
- t) Monitor or sponsor State legislation that proposes to change the structure of State and regional boards on which Long Beach is represented, and maximize the City's representation.
- u) Oppose legislative efforts to preempt campaign finance laws instituted by local ordinances, such as the City's Proposition M.
- v) Support policies and legislation to reduce the overconcentration of drug and alcohol recovery facilities by specifying that a required distance be maintained between facilities.
- w) Support efforts to enhance access, accommodations, and visit ability in dwellings and businesses for all of Long Beach's residents.
- x) Support efforts to reform the Regional Housing Needs Assessment.
- y) Support efforts to modify redevelopment rents to bring them in line with California Housing and Community Development (HCD) and tax credit program rents.

### **2. Support increased flexible State and County funding for local initiatives**

- a) Support legislation that allows the County of Los Angeles to conduct an election to implement a fee to improve

storm water systems and water quality, provided Long Beach receives an appropriate benefit in the proposed measure.

- b) Support policies, legislation and grants for the maintenance of existing oil property infrastructure, repair and improvement.
- c) Support the full funding of the State's future obligation for abandonment and cleanup of oil fields located in the Long Beach Tidelands.
- d) Support an equitable distribution of regional transportation dollars to cities, as well as legislation that increases funding for transportation programs and projects in Long Beach.
- e) Support policies and legislation to ensure the fair allocation of tax credits for the Southern California region and prioritize local control over allocation of affordable housing tax credits.
- f) Support policies, legislation and grants to maximize funding and funding flexibility for the development and enhancement of affordable and/or accessible housing within the City.
- g) Support the development of allowable uses for Low to Moderate Funds for cities that have met their affordable housing requirements in past planning cycles.
