RECOMMENDATION:

Authorize the Director of Parks, Recreation and Marine to assign Fitness Provider Permit No. 33008 with Fitness Through Motion, Inc., a California Corporation, to Karolina Soltani the corporation's new owner and execute all necessary documents.

Or

Authorize the Director of Parks, Recreation and Marine to execute all documents necessary for the termination of Fitness Provider Permit No. 33008 with Fitness Through Motion, Inc. (District 3).

DISCUSSION

At the Parks and Recreation Commission (Commission) meeting of November 16, 2017, the Commission received a report on issues related to previously approved Use and Fitness Provider Permits (Permits). The report concluded that the for-pay or commercial recreational activities that occur under these Permits as private businesses, and not part of the Departments Contract Class Program, should either meet certain requirements (that had not been imposed upon approval) or should have received a Conditional Use Permit from the City's Planning Commission pursuant to zoning regulations. In response to this report and because existing permittees have operated in good faith, the Commission directed the Director of the Department of Parks, Recreation and Marine (Department) to honor all currently active Permits through the earlier date of September 30, 2019 or effective date of the new policy that is currently being developed.

On July 16, 2015, the Commission authorized an extension of Fitness Provider Permit No. 33008 (Permit 33008) with Fitness Through Motion, Inc., (FTM) through January 31, 2020, for the conduct of a boot camp in Recreation Park. FTM subsequently received approval to move to Marina Vista Park, for an annual fee of \$350 per year. The Department of Parks, Recreation and Marine (Department) has received a request for approval of a change of ownership of FTM that occurred in 2017 (Attachment A). One of the provisions of Permit 33008 is that it cannot be assigned or transferred. As FTM is a corporation (as opposed to an individual or sole proprietor), the sale of a corporate entity could be considered a change of ownership and a prohibited transfer under the Permit provisions. The City Attorney's Office has suggested that the Commission make the policy determination whether its directive to temporarily grandfather existing Permits would apply to all

permittees regardless of their ownership structure, and whether to allow for the assignment or transfer of this Permit.

FISCAL IMPACT

If the transfer of Permit 33008 is allowed, there will be no fiscal impact. If the permit is cancelled, there would be a loss of \$350 to the Department in revenue to the General Fund.
