11	WHEREAS, the Charter of the City of Long Beach (the "City"), Section			
12	1802, permits the City to purchase services, supplies, materials, equipment and labor			
13	with other government agencies by purchasing under their contracts on a voluntary and			
14	selective basis when authorized by resolution; and			
15	WHEREAS, the City desires to purchase two Pierce Arrow XT aerial fire			
16	ladder trucks ("Fire Trucks"); and			
17	WHEREAS, the HOUSTON-GALVESTON AREA COUNCIL ("HGAC") has			
18	an Agreement with PIERCE MANUFACTURING INC. ("Pierce") for the purchase of these			
19	Fire Trucks, Agreement No. FS12-17 ("Agreement"); and			
20	WHEREAS, although the original HGAC Agreement was with Pierce,			
21	SOUTH COAST FIRE EQUIPMENT, INC. ("SCFE"), assumed Pierce's contractual			
22	obligations for specific areas, under the HGAC Agreement; and			
23	WHEREAS, the City's participation in the Agreement will facilitate			
24	acquisition of these Fire Trucks as well as provide considerable cost benefits to the City;

26	WHEREAS, if the City had to go to formal bid rather than participate in the			
27	Agreement considerably more funds would be required;			
28	NOW, THEREFORE, the City Council of the City of Long Beach resolves as

The above recitals are true and correct and are incorporated 2 Section 1. 3 herein by this reference.

The City Manager or designee of the City is hereby authorized Section 2. 4 to enter an agreement with SCFE to purchase two Pierce Arrow XT aerial fire ladder trucks of substantially the same type and kind purchased by the HGAC pursuant to the 6 Agreement except as modified by mutual agreement of the City and SCFE, and the purchase by the City shall be on the same terms and conditions afforded to the HGAC in 8 an amount not to exceed Two Million Nine Hundred Thirteen Thousand Dollars 9 10 (\$2,913,000) including taxes and fees.

This resolution shall take effect immediately upon its adoption 11 Section 3. by the City Council, and the City Clerk shall certify the vote adopting this resolution. 12
