## RECOMMENDATION:

Adopt resolutions declaring the official results of the City of Long Beach Primary Nominating Election held on April 10, 2018.

## DISCUSSION

It is recommended that the City Council adopt the attached resolutions relating to the City of Long Beach Primary Nominating Election held on April 10, 2018, titled as follow:

1. A resolution of the City Council of the City of Long Beach declaring the results of the Primary Nominating Election held in the City of Long Beach, California, on Tuesday, April 10, 2018, for the purpose of nominating and/or electing a candidate for the offices of Mayor, (4) offices on the City Council from District Numbers 3, 5, 7, and 9; and directing the City Clerk to place on the General Municipal Election to be held on the 5<sup>th</sup> day of June 2018, the names of the candidates declared to have been nominated by the Primary Nominating Election; and directing the City Clerk to issue a Certificate of Election to the candidate declared to have been elected at the Primary Nominating Election.
2. A resolution of the City Council of the City of Long Beach certifying the results of the Primary Nominating Election held in the City of Long Beach, California, on Tuesday, April 10, 2018, for the purpose of nominating and/or electing candidates for one (1) office on the Board of Education of the Long Beach Unified School District Area 3, and one (1) office on the Board of Trustees of the Long Beach Community College District Area 1.
3. A resolution proclaiming, calling, giving notice of and providing for the holding of a General Municipal Election to be held in the City of Long Beach on Tuesday, June 5, 2018, for the election of City Councilmember from the Fifth and Seventh Districts designating the ballot listing and adopting provisions relating to translations of and charges for the costs of candidate statements.
4. Adopt resolution ordering, proclaiming, calling, giving notice of and providing for the holding of a General Municipal Election to be held in the City of Long Beach on Tuesday, June 5, 2018, for the election of Governing Board Member of the Long Beach Unified School District Area 3 for a full term of four (4) years commencing with the third Monday of July, 2018; designating the ballot listing of the candidates to be voted on; and adopting provisions relating to the translations of and the charges for costs of candidate statements.

To meet the foregoing requirements, the Office of the City Clerk has executed the following tasks:

- a) An inspection of all materials and supplies returned by poll workers;
- b) A reconciliation of the number of signatures on the roster with the number of ballots recorded on the ballot statement;

- c) A reconciliation of the number of ballots counted, spoiled, canceled, or invalidated due to identifying marks and over votes, with the number of votes recorded by the vote counting system, which includes vote-by-mail and provisional ballots;
- d) Processing and counting any valid vote by mail and provisional ballots not included in the Election Day semifinal official canvass;
- e) Counting any valid write-in votes;
- f) Reproducing any damaged ballots, if necessary;
- g) Reporting final results to the governing board;
- h) Conduct of a public hand-count of ballots cast in a randomly selected one percent (1%) of precincts, plus one additional precinct for each race tabulated by the City's voting system; and
- i) Identification and reporting of any discrepancies between the vote system count and the hand count.

This matter was reviewed by Deputy City Attorney Amy Webber on April 9, 2018.

#### TIMING CONSIDERATIONS

Pursuant to Long Beach Municipal Code Section 1.21.010, the City Clerk is required to certify the election results to the City Council within twenty-one days after the date of the April 10, 2018, Primary Nominating Election. Los Angeles Registrar-Recorder/County Clerk requires the certification of our election by April 19, 2018 to consolidate with their election. Certification of the election must comply with the official canvass requirements set forth in the California Elections Code, Section 10264.

#### FISCAL IMPACT

A budget adjustment will be applied during the third quarter FY 18 for expenses relating to the April 10, 2018, Primary Nominating Election.

23 the Mayor and four (4) offices of the City Council namely, for the Third, Fifth, Seventh,  
24 and Ninth Districts; and

25 WHEREAS, the election was held in the City of Long Beach on that day;

25 candidates for this office, Rex Richardson is declared elected to the office of Member of  
26 the City Council from the Ninth District for the full term of four (4) years commencing with  
27 the third Tuesday of July, 2018. The City Clerk is directed to issue to Rex Richardson a  
28 Certificate of Election certifying to the election to this office for such term.

WHEREAS, the City Council of the City of Long Beach did, by Resolution No. RES-17-0125, duly call and provide for the holding of a Primary Nominating Election on Tuesday, April 10, 2018, for the purpose of nominating and/or electing candidates for the office of Mayor and the offices on the City Council namely, for the Third, Fifth, Seventh and Ninth Districts; and

WHEREAS, on October 24, 2017, the City Council adopted Resolution No. RES-17-0127 consenting to the requests of the Board of Education of the Long Beach Unified School District and the Board of Trustees of the Long Beach Community College District to consolidate the Governing Board Member elections for said Districts pursuant to the provisions of Section 10400 of the California Elections Code with the City's Primary Nominating Election for the purpose of nominating and/or electing candidates for one (1) office on the Board of Education of the Long Beach Unified School District for a full term of four (4) years, commencing on the third Monday of July, 2018, and for one (1) office on the Board of Trustees of the Long Beach Community College District, for a full term of four (4) years, commencing with the first day of the calendar month next succeeding his

1 or her election; and

2 WHEREAS, the consolidated election was held in the City of Long Beach  
3 on April 10, 2018; and

4 WHEREAS, the City Clerk, pursuant to Long Beach Municipal Code Section  
5 1.21.010, duly canvassed the returns of the election, including the Vote by Mail ballots  
6 issued in connection with the election which were returned as required by law;

7 NOW, THEREFORE, the City Council of the City of Long Beach resolves as  
8 follows:

9 Section 1. That the Vote by Mail ballots issued in connection with the  
10 election which have been returned as required by law have been duly canvassed, and  
11 the results of that count have been recorded. That the City Clerk has duly canvassed the



A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH ORDERING, PROCLAIMING, CALLING, GIVING NOTICE OF AND PROVIDING FOR THE HOLDING OF A GENERAL MUNICIPAL ELECTION TO BE HELD IN THE CITY OF LONG BEACH ON TUESDAY, THE 5TH DAY OF JUNE, 2018, FOR THE ELECTION OF TWO (2) CITY COUNCILMEMBERS FROM THE FIFTH AND SEVENTH COUNCIL DISTRICTS, FOR A FULL TERM OF FOUR (4) YEARS COMMENCING WITH THE THIRD TUESDAY OF JULY, 2018; DESIGNATING THE BALLOT LISTING OF THE CANDIDATES TO BE VOTED ON; AND ADOPTING PROVISIONS RELATING TO THE TRANSLATIONS OF AND THE CHARGES FOR COSTS OF CANDIDATE STATEMENTS

WHEREAS, the City Council of the City of Long Beach, by Resolution No. RES-17-0125, duly called and provided for the holding of a Primary Nominating Election on Tuesday, April 10, 2018; and

WHEREAS, the Primary Nominating Election was held in the City of Long Beach on Tuesday, April 10, 2018, and certain candidates have been nominated for the office of Councilmember for the Fifth and Seventh City Council Districts; and

WHEREAS, in accordance with applicable law, it is necessary for the City Council to order, proclaim and call a General Municipal Election for the election of Councilmembers for the Fifth and Seventh City Council Districts;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:



1 polling place after 8:00 p.m. shall be entitled to vote, although the polls may be open  
2 when such person arrives.

3           Section 6.     California Elections Code Section 13307 requires that a  
4 candidate's statement must be translated in Spanish at the candidate's request. Further,  
5 in accordance with the requirements of the federal Voting Rights Act of 1965 (PL 94-73)  
6 all candidates' statements shall be translated into the languages indicated for Member of  
7 the City Council for the Fifth and Seventh Council Districts as follows: Khmer, Korean,  
8 Spanish, Tagalog, and Vietnamese. Any translations into the required languages shall  
9 be available in the City Clerk's office upon request. A candidate shall not be required to  
10 pay for the cost of translating his or her candidate's statement into any foreign language  
11 required pursuant to federal and/or state law. However, a candidate shall be required to  
12 pay the cost of printing the candidate's statement in the sample ballot pamphlet in a  
13 foreign language.

14           Section 7.     Pursuant to Section 13307 of the California Elections Code, a  
15 charge shall be levied against each candidate for the costs of the candidate's statements  
16 sent to each voter. The City Clerk is directed and authorized to establish and implement  
17 the charge for the costs of printing, handling, translating, and mailing any candidate  
18 statements as provided in Elections Code Section 13307. Any allegation of indigency or  
19 inability to pay the requisite fee in advance shall be handled by the City Clerk in  
20 accordance with the provisions of Elections Code Section 13309, and in such instances  
21 the candidate's statement shall only be published in the English/Spanish language.

22           Section 8.     Candidates will have up to five (5) days following the April 10,  
23 2018 Primary Nominating Election to change their candidate statement.

24           Section 9.     The City Clerk shall provide each candidate or the candidate's  
25 representative with a copy of the resolution.

26           Section 10.    This resolution shall take effect immediately upon its adoption  
27 by the City Council, and the City Clerk shall certify the vote adopting this resolution.

WHEREAS, in accordance with applicable law, it is necessary for the City Council to order, proclaim and call a General Municipal Election for the election of Long Beach Unified School District Board Member Area 3;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:



1 Khmer, Korean, Spanish, Tagalog, and Vietnamese. Any translations into the required  
2 languages shall be available in the City Clerk's office upon request. A candidate shall not  
3 be required to pay for the cost of translating his or her candidate's statement into any  
4 foreign language required pursuant to federal and/or state law. However, a candidate  
5 shall be required to pay the cost of printing the candidate's statement in the sample ballot  
6 pamphlet in a foreign language.

7 Section 6. Pursuant to Section 13307 of the California Elections Code, a  
8 charge shall be levied against each candidate for the costs of the candidate's statements  
9 sent to each voter. The City Clerk is directed and authorized to establish and implement  
10 the charge for the costs of printing, handling, translating, and mailing any candidate  
11 statements as provided in Elections Code Section 13307. Any allegation of indigency or  
12 inability to pay the requisite fee in advance shall be handled by the City Clerk in  
13 accordance with the provisions of Elections Code Section 13309, and in such instances  
14 the candidate's statement shall only be published in the English/Spanish language.

15 Section 7. Candidates will have up to five (5) days following the April 10,  
16 2018 Primary Nominating Election to change their candidate statement.

17 Section 8. The City Clerk shall provide each candidate or the candidate's  
18 representative with a copy of the resolution.

19 Section 9. This resolution shall take effect immediately upon its adoption  
20 by the City Council, and the City Clerk shall certify the vote adopting this resolution.
