RECOMMENDATION:

Adopt resolutions declaring the official results of the City of Long Beach Primary Nominating Election held on April 10, 2018.

DISCUSSION

It is recommended that the City Council adopt the attached resolutions relating to the City of Long Beach Primary Nominating Election held on April 10, 2018, titled as follow:

- 1. A resolution of the City Council of the City of Long Beach declaring the results of the Primary Nominating Election held in the City of Long Beach, California, on Tuesday, April 10, 2018, for the purpose of nominating and/or electing a candidate for the offices of Mayor, (4) offices on the City Council from District Numbers 3, 5, 7, and 9; and directing the City Clerk to place on the General Municipal Election to be held on the 5th day of June 2018, the names of the candidates declared to have been nominated by the Primary Nominating Election; and directing the City Clerk to issue a Certificate of Election to the candidate declared to have been elected at the Primary Nominating Election.
- 2. A resolution of the City Council of the City of Long Beach certifying the results of the Primary Nominating Election held in the City of Long Beach, California, on Tuesday, April 10, 2018, for the purpose of nominating and/or electing candidates for one (1) office on the Board of Education of the Long Beach Unified School District Area 3, and one (1) office on the Board of Trustees of the Long Beach Community College District Area 1.
- 3. A resolution proclaiming, calling, giving notice of and providing for the holding of a General Municipal Election to be held in the City of Long Beach on Tuesday, June 5, 2018, for the election of City Councilmember from the Fifth and Seventh Districts designating the ballot listing and adopting provisions relating to translations of and charges for the costs of candidate statements.
- 4. Adopt resolution ordering, proclaiming, calling, giving notice of and providing for the holding of a General Municipal Election to be held in the City of Long Beach on Tuesday, June 5, 2018, for the election of Governing Board Member of the Long Beach Unified School District Area 3 for a full term of four (4) years commencing with the third Monday of July, 2018; designating the ballot listing of the candidates to be voted on; and adopting provisions relating to the translations of and the charges for costs of candidate statements.

To meet the foregoing requirements, the Office of the City Clerk has executed the following tasks:

- a) An inspection of all materials and supplies returned by poll workers;
- b) A reconciliation of the number of signatures on the roster with the number of ballots recorded on the ballot statement;

- c) A reconciliation of the number of ballots counted, spoiled, canceled, or invalidated due to identifying marks and over votes, with the number of votes recorded by the vote counting system, which includes vote-by-mail and provisional ballots;
- d) Processing and counting any valid vote by mail and provisional ballots not included in the Election Day semifinal official canvass;
- e) Counting any valid write-in votes;
- f) Reproducing any damaged ballots, if necessary;
- g) Reporting final results to the governing board;
- h) Conduct of a public hand-count of ballots cast in a randomly selected one percent (1%) of precincts, plus one additional precinct for each race tabulated by the City's voting system; and
- i) Identification and reporting of any discrepancies between the vote system count and the hand count.

This matter was reviewed by Deputy City Attorney Amy Webber on April 9, 2018.

TIMING CONSIDERATIONS

Pursuant to Long Beach Municipal Code Section 1.21.010, the City Clerk is required to certify the election results to the City Council within twenty-one days after the date of the April 10, 2018, Primary Nominating Election. Los Angeles Registrar-Recorder/County Clerk requires the certification of our election by April 19, 2018 to consolidate with their election. Certification of the election must comply with the official canvass requirements set forth in the California Elections Code, Section 10264.

FISCAL IMPACT

A budget adjustment will be applied during the third quarter FY 18 for expenses relating to the April 10, 2018, Primary Nominating Election.

WHEREAS, the City Council of the City of Long Beach, by Resolution No. RES-17-0125, duly called and provided for the holding of a Primary Nominating Election on Tuesday, April 10, 2018; and

WHEREAS, the Primary Nominating Election was held in the City of Long Beach on Tuesday, April 10, 2018, and certain candidates have been nominated for the office of Councilmember for the Fifth and Seventh City Council Districts; and

WHEREAS, in accordance with applicable law, it is necessary for the City Council to order, proclaim and call a General Municipal Election for the election of Councilmembers for the Fifth and Seventh City Council Districts;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:

Section 1. Pursuant to the provisions of the Constitution and laws of the State of California and the provisions of the Charter of the City of Long Beach governing the holding of municipal elections, a General Municipal Election is ordered, proclaimed and called to be held in the City of Long Beach, California, between the hours of 7:00 a.m. and 8:00 p.m. on the 5th day of June, 2018, for the purpose of electing a Member of the City Council for the Fifth and Seventh Council Districts, for a full term of four (4) years, commencing with the third Tuesday of July, 2018.

Section 2. The following list of candidates which has been regularly certified by the City Clerk sets forth the candidates nominated as required by law for the office of Member of the City Council for the Fifth Council District, and is in the order of the randomized alphabet selected by the Secretary of State:

Section 4. Notice is given of the holding and of the time and place of the election.

Section 5. The polls for the General Municipal Election shall be open at 7:00 a.m. and shall be kept open until 8:00 p.m. when the polls shall be closed; except that, if at the hour of closing there are any voters in the polling place or in line at the door who are qualified to vote, and who have not been able to do so since appearing, the polls shall be kept open a sufficient time to enable them to vote; but no one who arrives at the

polling place after 8:00 p.m. shall be entitled to vote, although the polls may be open when such person arrives.

Section 6. California Elections Code Section 13307 requires that a candidate's statement must be translated in Spanish at the candidate's request. Further, in accordance with the requirements of the federal Voting Rights Act of 1965 (PL 94-73) all candidates' statements shall be translated into the languages indicated for Member of the City Council for the Fifth and Seventh Council Districts as follows: Khmer, Korean, Spanish, Tagalog, and Vietnamese. Any translations into the required languages shall be available in the City Clerk's office upon request. A candidate shall not be required to pay for the cost of translating his or her candidate's statement into any foreign language required pursuant to federal and/or state law. However, a candidate shall be required to pay the cost of printing the candidate's statement in the sample ballot pamphlet in a foreign language.

Pursuant to Section 13307 of the California Elections Code, a Section 7. charge shall be levied against each candidate for the costs of the candidate's statements sent to each voter. The City Clerk is directed and authorized to establish and implement the charge for the costs of printing, handling, translating, and mailing any candidate statements as provided in Elections Code Section 13307. Any allegation of indigency or inability to pay the requisite fee in advance shall be handled by the City Clerk in accordance with the provisions of Elections Code Section 13309, and in such instances the candidate's statement shall only be published in the English/Spanish language.

Candidates will have up to five (5) days following the April 10, Section 8. 2018 Primary Nominating Election to change their candidate statement.

Section 9. The City Clerk shall provide each candidate or the candidate's representative with a copy of the resolution.

Section 10. This resolution shall take effect immediately upon its adoption by the City Council, and the City Clerk shall certify the vote adopting this resolution.

Section 3. Notice is given of the holding and of the time and place of the election.

Section 4. The polls for the General Municipal Election shall be open at 7:00 a.m. and shall be kept open until 8:00 p.m. when the polls shall be closed; except that, if at the hour of closing there are any voters in the polling place or in line at the door who are qualified to vote, and who have not been able to do so since appearing, the polls shall be kept open a sufficient time to enable them to vote; but no one who arrives at the polling place after 8:00 p.m. shall be entitled to vote, although the polls may be open when such person arrives.

Section 5. California Elections Code Section 13307 requires that a candidate's statement must be translated in Spanish at the candidate's request. Further, in accordance with the requirements of the federal Voting Rights Act of 1965 (PL 94-73) all candidates' statements shall be translated into the languages indicated as follows:

Khmer, Korean, Spanish, Tagalog, and Vietnamese. Any translations into the required languages shall be available in the City Clerk's office upon request. A candidate shall not be required to pay for the cost of translating his or her candidate's statement into any foreign language required pursuant to federal and/or state law. However, a candidate shall be required to pay the cost of printing the candidate's statement in the sample ballot pamphlet in a foreign language.

Section 6. Pursuant to Section 13307 of the California Elections Code, a charge shall be levied against each candidate for the costs of the candidate's statements sent to each voter. The City Clerk is directed and authorized to establish and implement the charge for the costs of printing, handling, translating, and mailing any candidate statements as provided in Elections Code Section 13307. Any allegation of indigency or inability to pay the requisite fee in advance shall be handled by the City Clerk in accordance with the provisions of Elections Code Section 13309, and in such instances the candidate's statement shall only be published in the English/Spanish language.

Section 7. Candidates will have up to five (5) days following the April 10, 2018 Primary Nominating Election to change their candidate statement.

The City Clerk shall provide each candidate or the candidate's Section 8. representative with a copy of the resolution.

This resolution shall take effect immediately upon its adoption Section 9. by the City Council, and the City Clerk shall certify the vote adopting this resolution.
