WHEREAS, the City Council of the City of Long Beach did, by Resolution

Seventh and Ninth Districts; and

19 WHEREAS, on October 24, 2017, the City Council adopted Resolution No. 20 RES-17-0127 consenting to the requests of the Board of Education of the Long Beach 21 Unified School District and the Board of Trustees of the Long Beach Community College 22 District to consolidate the Governing Board Member elections for said Districts pursuant 23 to the provisions of Section 10400 of the California Elections Code with the City's Primary 24 Nominating Election for the purpose of nominating and/or electing candidates for one (1) 25 office on the Board of Education of the Long Beach Unified School District for a full term 26 of four (4) years, commencing on the third Monday of July, 2018, and for one (1) office on 27 the Board of Trustees of the Long Beach Community College District, for a full term of 28 four (4) years, commencing on the third Monday of July, 2018; and


