

FIRST AMENDMENT TO AGREEMENT NO. 34743

THIS FIRST AMENDMENT TO AGREEMENT NO. 34743 is made and entered, in duplicate, as of December 18, 2017, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on December 12, 2017, by and between MUNISERVICES, LLC, a Delaware limited liability company ("Consultant"), with a place of business at 7625 N. Palm Avenue, Suite 108, Fresno, California 93711, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with examining records relating to Sales or Transaction and Use Tax, collected by the California State Board of Equalization; and

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 34743 (the "Agreement") whereby Consultant agreed to provide these services; and

WHEREAS, the Parties desire to add \$38,000 and extend the term;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 1.A. of the Agreement is hereby amended to read as follows:

"A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, not to exceed Three Hundred Six Thousand Dollars (\$306,000), at the rates or charges shown in Exhibit "B"."

2. Section 2 of the Agreement is hereby amended to read as follows:

"2. TERM. The term of this Agreement shall commence at midnight on October 1, 2014, and shall terminate at 11:59 p.m. on August 31, 2018, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner."

3. Except as expressly modified herein, all of the terms and conditions

1 contained in Agreement No. 34743 are ratified and confirmed and shall remain in full force  
2 and effect.
