## FIRST AMENDMENT TO AGREEMENT NO. 34562 3 4 5 6 2

THIS FIRST AMENDMENT TO AGREEMENT NO. 34562 is made and entered, in duplicate, as of March 20, 2018, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on January 10, 2017, by and between SUPREME TOWING SERVICE, INC. DBA CITY TOW SERVICE, a California corporation ("Contractor"), with a place of business at 704 WEST 17TH ST., LONG BEACH, CA 90813, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with As Needed Towing Services ("Project"); and

WHEREAS, the parties entered Agreement No. 34562 whereby Contractor agreed to provide these services; and

WHEREAS, the parties desire to extend the term and add the annual amount of \$120,000 for a total not to exceed contract amount of \$270,000;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the parties agree as follows:

- 1. Section 1.A. of Agreement No. 34562 is hereby amended to read as follows:
  - "A. Contractor shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession and the terms and conditions stated herein, and City shall pay for these services in the manner described below, not to exceed One Hundred Fifty Thousand Dollars (\$150,000) annually for the period of May 1, 2016 through April 30, 2018, and the amount not to exceed One Hundred Twenty Thousand Dollars (\$120,000) annually for the period of May 1, 2018 through April 30, 2019, at the rates or charges shown in Exhibit "B"."

	2.	Section 2.	Of	Agreement	No.	34562	is hereby	amended	to	read	as
follows:											

- "2. <u>TERM.</u> The term of this Agreement shall commence at midnight on May 1, 2016, and shall terminate at 11:59 p.m. on April 30, 2019, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner. The parties have the option to extend the term for one (1) additional one-year period."
- 3. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 34562 are ratified and confirmed and shall remain in full force and effect.
