FIRST AMENDMENT TO AGREEMENT NO. 33845

THIS FIRST AMENDMENT TO AGREEMENT NO. 33845 is made and entered, in duplicate, as of March 8, 2018 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on April 7, 2015, by and between MICHAEL BAKER INTERNATIONAL, INC. formerly known as RBF CONSULTING, a Pennsylvania corporation ("Consultant"), whose address is 500 Grant Street, Suite 5400, Pittsburgh, Pennsylvania 15219, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with as-needed traffic engineering, transportation planning and related technical and professional services; and

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 33845 (the "Agreement") whereby Consultant agreed to provide these services; and

WHEREAS, the Parties desire to increase the amount by \$200,000 for a total not to exceed amount of \$600,000 and extend the term one (1) additional one-year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions here contained, the Parties agree as follows:

- 1. Section 1.A of the Agreement is hereby amended to read as follows:
- "A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, not to exceed Six Hundred Thousand Dollars (\$600,000), at the rates or charges shown in Exhibit "B"."
 - 2. Section 2 of the Agreement is hereby amended to read as follows:
- "2. <u>TERM.</u> The term of this Agreement shall commence at midnight on June 1, 2015, and shall terminate at 11:59 p.m. on May 31, 2019, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner.
