WHEREAS, the Energy Resources Department ("ER") requires gas meters and related services and parts; and

WHEREAS, historically, ER has installed Itron natural gas meters for its large commercial and industrial customers in Long Beach and Signal Hill; and

WHEREAS, ER staff is fully trained on the operation, maintenance, and repair of the Itron natural gas meters and parts which eliminates the need for additional staff training; and

WHEREAS, Meter, Valve & Control ("MVC") is the sole manufacturer and distributor of Itron meters and regulators used for light-duty commercial and residential customers; and

WHEREAS, no useful purpose would be served by advertising for bids and to do so would constitute an idle and useless act and an unnecessary expenditure of public funds;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:

Section 1. The City Manager is hereby authorized to enter a contract,
