A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AUTHORIZING THE CITY MANAGER OR DESIGNEE TO EXECUTE AN AGREEMENT WITH OFFICE DEPOT, INC. FOR DATA CENTER **TELECOMMUNICATIONS** SYSTEMS EQUIPMENT. EQUIPMENT, AND USER DEVICES, ON THE SAME TERMS AND CONDITIONS AFFORDED TO REGIONAL 4 **EDUCATION** SERVICE CENTER THROUGH INTERGOVERNMENTAL PURCHASING NATIONAL ALLIANCE THE COOPERATIVE **PURCHASING NETWORK** 

WHEREAS, the Charter of the City of Long Beach, Section 1802, permits the City Manager to enter into a contract on behalf of the City, in writing or otherwise, without advertising for bids, for services, supplies, materials, equipment or labor, with other government agencies, when authorized by resolution; and

WHEREAS, the City desires data center systems equipment, telecommunications equipment, and user devices; and

WHEREAS, Region 4 Education Service Center through National Intergovernmental Purchasing Alliance - The Cooperative Purchasing Network has a contract with Office Depot, Inc. for technology and interactive whiteboard products and services, Contract No. R160204 ("TCPN Contract"); and

WHEREAS, the City's participation in the TCPN Contract will facilitate timely acquisition of the data center systems equipment, telecommunications equipment, and user devices as well as provide considerable cost benefits to the City; and

WHEREAS, if the City had to go to formal bid rather than participate in the

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:

Section 1. The City Manager or designee is hereby authorized to enter an agreement with Office Depot, Inc. to furnish and deliver data center systems equipment, telecommunications equipment, and user devices, of the same kind identified in the TCPN Contract in an amount not to exceed Six Million Seven Hundred Seventy-Seven Thousand Nine Hundred Dollars (\$6,777,900) for the first year; thereafter, in an annual amount not to exceed One Million Five Hundred Eighty-Seven Thousand Dollars (\$1,587,000), for ongoing lifecycle replacement of equipment and new incremental technology growth, until the current contract expires on June 15, 2019, with the option to renew for as long as the TCPN Contract is in effect, as needed.

Section 2. This resolution shall take effect immediately upon its adoption by the City Council, and the City Clerk shall certify the vote adopting this resolution.
