## SECOND AMENDMENT TO AGREEMENT NO. 34195

THIS SECOND AMENDMENT TO AGREEMENT NO. 34195 is made and entered, in duplicate, as of May 24, 2018 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on October 20, 2015, by and between ARMIJO ENTERPRISES, INC. DBA BRADFIELD DESIGN, a California corporation ("Consultant"), with a place of business at 3101 East 2nd Street, Unit 6-A, Long Beach, California 90803, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, the City requires specialized services requiring unique skills to be performed in connection with as-needed graphic design and creative services; and

WHEREAS, City and Consultant (the "Parties") entered into Agreement No.

34195 (the "Agreement") whereby Consultant agreed to provide these services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to increase the Agreement amount by \$5,000 for a total not to exceed amount of \$38,000 and extend the term an additional one-year period; and

WHEREAS, the Parties desire to increase the Agreement amount by \$17,000 for a total not to exceed amount of \$55,000;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 1.A. of the Agreement is hereby amended to read as follows:
- "A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, not to exceed Fifty-Five Thousand Dollars (\$55,000), at the rates or charges shown in Exhibit "B"."
- 2. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 34195 are ratified and confirmed and shall remain in full force
