Mr. Chairman, Members of the Planning Commission:

My office represents Mr. and Mrs. Mark and Leanne Tornow in their request to operate a convenience market with a Type-20 (Off-Sale Beer and Wine) in conjunction with an existing gas station.

1. Background

The subject site was originally developed with a gas station built in the 1960's. The current owner and applicant took over the place in 1998 and operated a tow service as well as a gas and service station, which had 5 auto repair bays. The owner recently oversaw a major remodeling of the site, which removed the auto repair area, relocated the tow service, and converted the retail area into a Circle K convenience store that sells grocery items and has a fast food outlet, Krispy Krunchy Chicken, to serve the public. The renovated place has been open and in operation for almost two months.

The Planning Staff has stated that it cannot support the request to serve beer and wine at the gas station for two reasons. 1) The subject site is located in an area of overconcentration as defined by ABC and 2) it is located in a high crime area as defined by the Long Beach Police Department. We respectfully disagree with their findings and we will show how neither is the case for this address.

2. No change in the number of Type 20 licenses with this approval

At the time of the writing of the city staff report there were five, active off-sale licenses in operation in this census tract. Off-sale licenses are alcohol licenses that only permit the sale of alcohol for off-site consumption. Since the staff report writing the off-sale license at Rite Aid, located at 5545 E. Stearns Street, has been surrendered leaving

four active off-sale licenses, therefore, approving the requested license would not increase the number of licenses that were allowed and active in this area. For at least 11 years, five off-sale licenses operated in this area, with the surrender of one license and the approval of this request there would continue to be five off-sale licenses in this area. In addition, by approving this request it would create a more equal distribution of licenses in the Census Tract 5743 as four of the five previously approved licenses were concentrated in the western portion of the tract. Approving this license would create an area where three of the five licenses are in the western portion of the census tract and the other two licenses would service the eastern portion of census tract. Below are maps showing the current distribution of licenses in the census tract and how the tract would look if the request at 6370 E. Stearns was approved.





3. This market will be a benefit to the immediate neighborhood

While currently the number of licenses exceeds the limit of three off-sale licenses for the census tract, the Alcoholic Beverage Control permits a waiver of this rule if it can be determined that the issuance the license will be a benefit to the community and not a detriment to the area. The issuance of a license at 6370 E. Stearns Street, will be a benefit because, the concentration of alcohol licenses is on the opposite side of the census tract and does not serve the needs of the residents close to the subject site. Four of the five off-sale licenses are located on the west side of the census tract. Specifically, the licenses are with businesses located in the commercial area on the corner of Bellflower and Stearns Street, which is a mile away from 6370 E. Stearns. Issuance of a license to the subject site would be a benefit to the community because, they would be able to have a location to purchase beer and wine less than a mile from home, which would allow people to walk to some place nearby and purchase beer and wine instead of having to get in a car and drive to get it.

4. This convenience market provides many services to the community

The site at 6370 E. Stearns is a gas station, which is the first fueling option for many nearby residents. In fact, the location at 6370 E. Stearns provides gas for everyone within a mile radius from E. Spring Street in the north to E. Stearns in the south to Woodruff Street in the west and, Studebaker in the east. In addition to gasoline, people go there to buy grocery items, frozen foods, a fast food meal to go, and even propane gas. For such a place that provides so many vital services to the community it is logical that that such a place be a complete one-stop shop and permit people to purchase beer and wine as part of their trip to the convenience store/service station. Furthermore, selling beer and wine at 6370 E. Stearns would be a safe and convenient location for residents compared to their alternatives.

5. Selling alcohol at 6370 E. Stearns would be a safe alternative for residents

There is a liquor store EJM that is nearly 400 feet away from the subject property, however, it is not a convenient location for residents south of Stearns Street to get to. First, EJM liquor mart is located in a shopping center that is adjacent to a high traffic intersection. Once you access the shopping center it is very difficult to find parking because, it is home to several popular businesses such as Del Taco, Subway, Tutti Frutti Frozen Yogurt, and Starbucks. Permitting the sale of beer and wine at the subject site would mitigate all of these issues and improve the convenience of purchasing goods, thereby the overall quality of life of the neighborhood.

6. The community supports the sale of beer and wine at this location

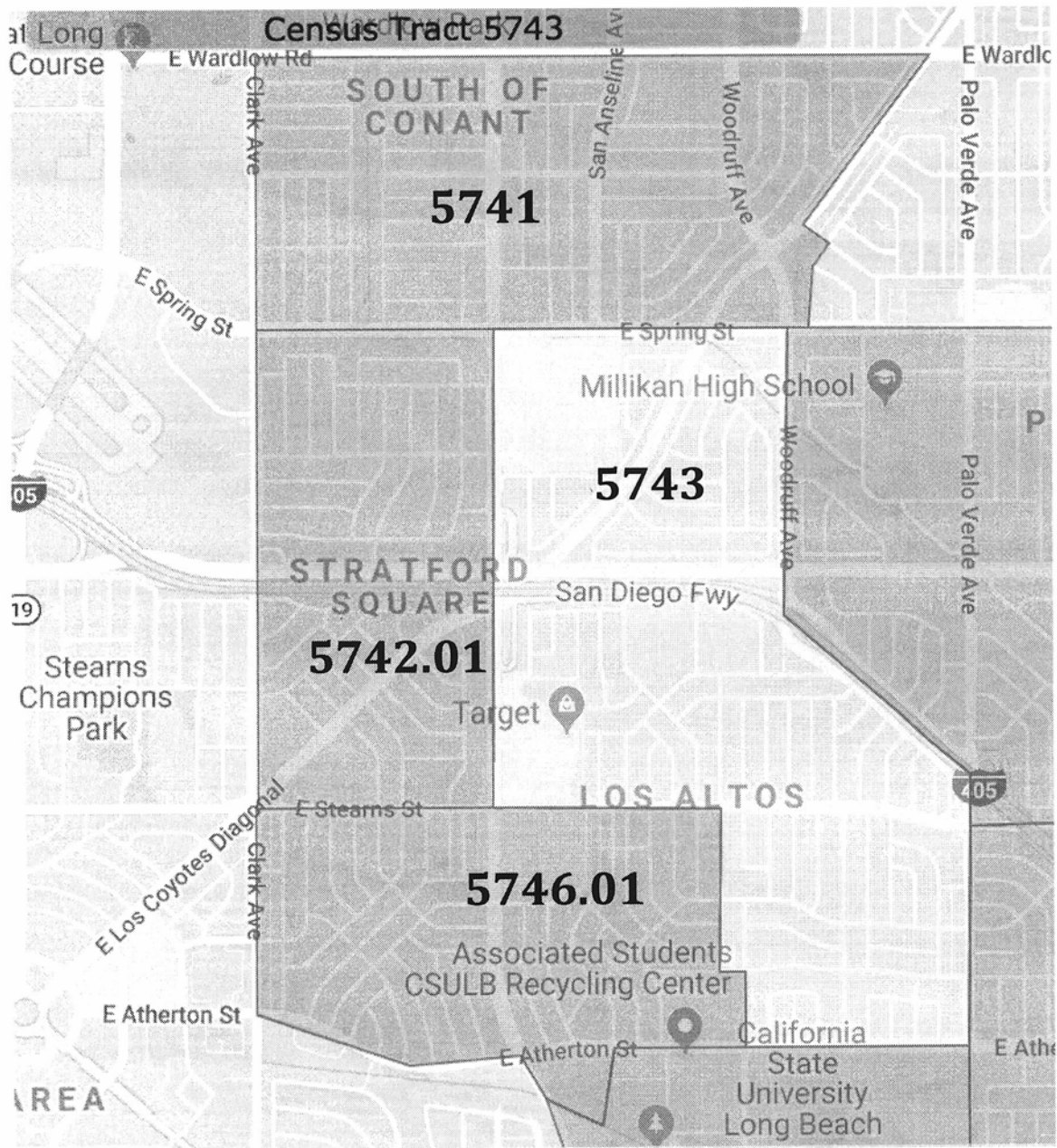
In November of 2017, the applicant went door to door to everyone within a 500-foot radius, told residents about the gas station that would be opened soon, and asked if they would sign a survey in support of the gas station selling beer and wine for off-site consumption. Nearly all of the residents surveyed signed in support of the request to serve beer and wine because, it would either allow them to buy gas, groceries, a meal, and beer and wine all in one place. Or, it would give them the option to be able to walk to a nearby place and purchase some alcoholic beverages.

Since the operation's opening in May 2018, patrons of the store have signed a petition in support of the sell of beer and wine at the location. At the time of the writing of this document the business has received over 1,000 signatures in support of selling beer and wine at the subject site. Attached at the end of this document are copies of the signatures from nearby residents and patrons of the convenience store who support the applicant's request to sell beer and wine for off-site consumption.

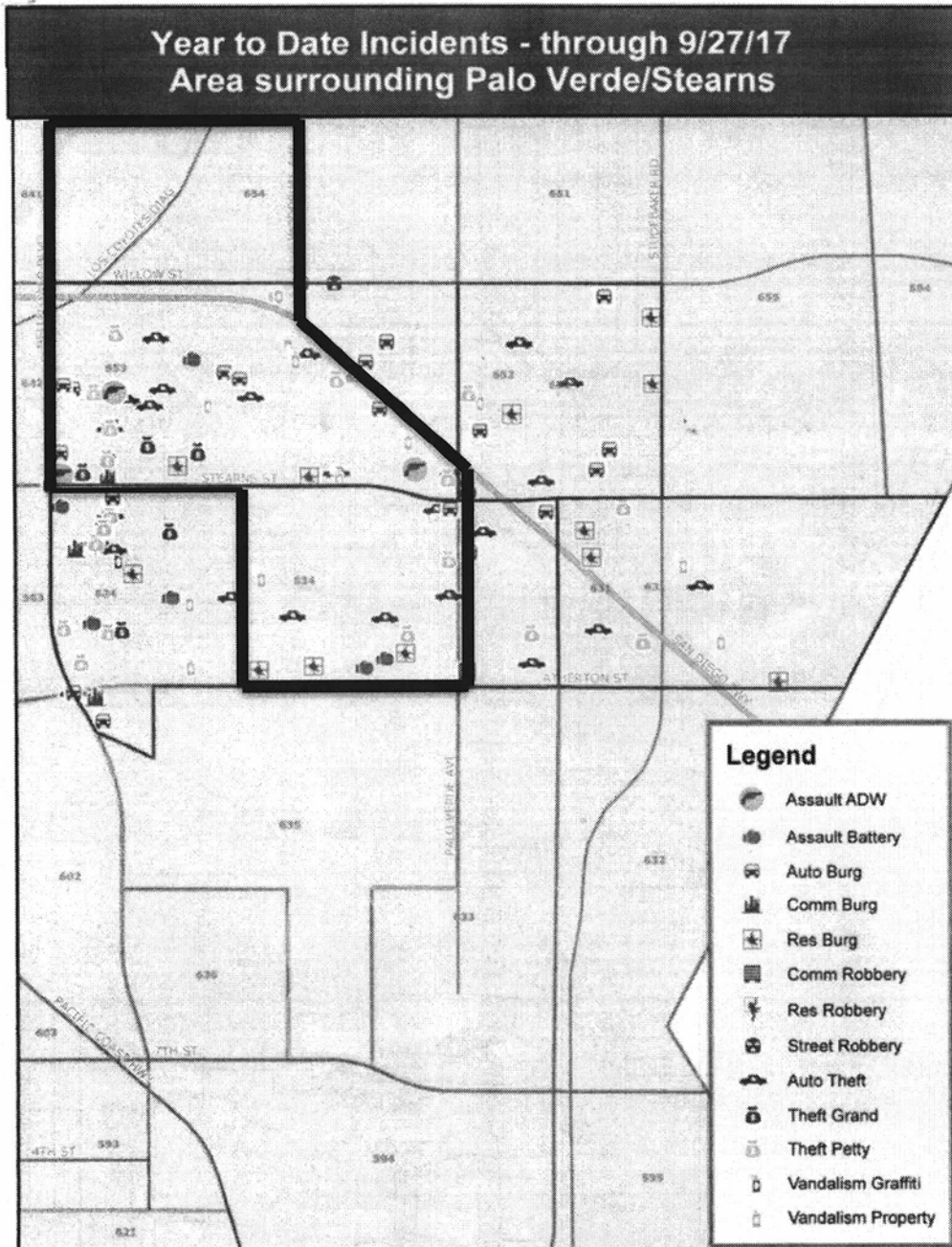
7. The data saying this is a high crime area is misleading

The next issue is the Circle K/gas station is listed as being in a high crime area. This is based on crime data provided by the Long Beach Police Department. However, the reason the census tract has a high crime rate is due to factors that are out of its control, namely the size of the tract is much larger than neighboring census tracts. The subject site is in Census Tract 5743; it is approximately one square mile in area. The neighboring census tracts such as 5741, 5742.01, 5746.01, and 5749.01 are only a half square mile in area, therefore, more crimes occur in census tract 5743 than other tract

because it covers a larger area. Immediately below this paragraph is a map of Census Tract 5743 and the adjacent tracts. As you can see it is significantly larger than other census tracts, which explains why it contains higher crime numbers than nearby tracts.



Below is a crime statistics map of census tract 5743. As you can see the majority of crime that occurred in the area happened in the western section of the census tract. The subject site is on the opposite side of the tract in the eastern side. The criminal activity in the eastern section of the tract was much less. And if the census tract was the same size as adjacent tract, which are only one-half square mile in size as opposed to one full square mile in size the crime rate would be so low as to be considered a low crime area.



8. The officers who patrol this area say it is a low crime area

While the crime data may say one thing, one group of people who truly know the safety of this neighborhood are the officers who are assigned to protect it. The police who actually patrol the area around 6370 E. Stearns Street say this site and the surrounding neighborhood are not in a high crime area. Attached to this report is a letter from Officer Neely. He has worked in law enforcement in this area for 30 years. In his letter he states that 6370 E. Stearns is not in a high crime area and, does not believe the issuance of a beer and wine license at this location would be a detriment to the community.

Another officer, Officer Miles who has patrolled the area for years actually laughed when the applicant told him that the city considers this to be a high crime area. He said it is not. Furthermore, he asked that if this were really true then why is it that only one patrol car is assigned to this area? Portions of the city where there is a lot of crime activity such as East Village, Rose Park South, and the Eastside neighborhoods are locales with high crime rates that have several cars patrol the area during one shift. According to the crime activity website neighborhoodscout.com, the neighborhood 6370 E. Stearns is in is one of the safest places in the city.

9. The residents who live in this area say it is a safe neighborhood

Lastly, the applicant went door to door to let residents know about the proposed gas station that was opening and ask them if they had any concerns about the request to sell alcohol. All of the residents except one said they supported the request to sell beer and wine at the site, signed the survey in support of the request, and many laughed or had a look of disbelief on their face when the applicant told them that the city stated this was a high crime area. One anecdotal story is one of the co-owners, Mark Tornow, spoke with a resident about the request to serve beer and wine at Circle K and Mr. Tornow learned that the resident was a building inspector in a nearby city. When Mr. Tornow told the man that the city said his neighborhood was considered a high crime area, he said that he did not believe that because, he moved into that neighborhood precisely because it was a safe neighborhood and has had no problems since he moved there. So based on the nearly 60 residents who think it is a safe neighborhood and signed a survey in support of serving beer and wine at the gas station, the applicant believes this proves the area is safe, definitely not a high crime area, and selling beer and wine would not be a detriment to the surrounding community.

10. Conclusion

Leanne and Mark Tornow are the operators of the gas station and Circle K convenience store at 6370 E. Stearns Street in Long Beach. They wish to sell beer and wine for off-site consumption at their store. The city planning staff recommended denial of the request because there is an overconcentration of off-sale alcohol licenses in the area and, the crime statistics say the area in question is a high crime area. However, if this license is approved it would not create an increase in the number of licenses in the area. Since 2007, there were 5 businesses in the census tract that had an off-sale license. The Rite Aid store on Stearns Street recently surrendered their license reducing the number to four. Approving this CUP would keep the same number of licenses that has operated in this area for the last 11 years. Also, approval of this license would better distribute the alcohol licenses throughout the census tract as 4 of the 5 licenses were located in the western portion of the census tract, while only one is located in the eastern portion. If this license was granted then the tract would have 3 licenses in the western section and two in the eastern section, making it more equitable and accessible for all the residents of the census tract.

The second reason the city would not support the license request is because the crime data states that this neighborhood is a high crime area. A more thorough analysis of the data shows that is not the case. One reason the crimes statistics are higher in this

census tract than others is that it is a larger census tract. Census Tract 5743, the tract in question, is nearly twice the physical size of the three tracts that are adjacent to it. The high number of reported crimes is a result of crimes being reported in a larger area than neighboring tracts. In addition, the police who patrol this area state that it is not a high crime area. One officer told the applicant that the neighborhood around the subject site is not a high crime area. Another officer who has patrolled this neighborhood for over 30 years wrote a letter, in which he listed his phone number for follow up phone calls, stating the same thing. Lastly, the owners went door to door and spoke to their neighbors about the convenience store selling beer and wine. When they spoke to the residents and told them the city stated this was a high crime area, the residents said it was not and they signed the survey in support of the convenience store selling beer and wine. Based on all the information presented, we believe we have shown how the two reasons for recommending denial are inaccurate and granting such a license would add convenience for the neighbors and therefore, be a benefit to the community.

Findings:

- A. The operator of the use shall provide parking for the use equivalent to the parking required for new construction regardless of the status of the previous use as to legal nonconforming rights; The applicant has recently renovated the site, built the site to current development standards, and has received a certificate of occupancy to operate in the redeveloped space. As a requirement of building to current development standards the business owner had to provide parking that is required for new construction. Earlier this year City Planner Cuentin Jackson went to the site and performed a site inspection in which he confirmed the business provided all of the required parking. Therefore, the applicant has satisfied this finding.
- B. The operator of the use shall provide night lighting and other security measures to the satisfaction of the Chief of Police; As part of the renovation the applicant installed more than the required number of night lighting and security cameras on the building. Specifically, the business owner installed night lighting on the rear and side of the building, which illuminates the alley that is behind the service station and placed lighting and cameras everywhere that was thought to be a potential safety hazard. District 4 Councilman Supernaw also inspected the site and saw all of the safety measures installed on the property and, attended the grand opening of the store to show his support of the establishment. Therefore, the applicant has satisfied this finding.
- C. The operator of the use shall prevent loitering or other activity in the parking lot that would be a nuisance to adjacent uses and/or residential neighborhoods; The applicant has security cameras that monitor the entire property and has trained staff on how to deal with someone loitering on the site. Co-owner Mark Tornow also went door to door to notify nearby residents about the opening of the convenience store and ask them if they supported beer and wine being sold there. As a way to show his commitment to the community and ensure his place

would never become a nuisance to neighbors he has given all the people who signed his letter of support his personal cell phone number, so if there is a disturbance they can notify him directly and immediately.

- D. The use shall not be in a reporting district with more than the recommended maximum concentration of the applicable on or off-premises sales use, as recommended by the State of California Alcoholic Beverage Control Board, nor with a high crime rate as reported by the Long Beach Police Department, except: (1) locations in the greater downtown area; or (2) stores of more than twenty thousand (20,000) square feet floor area, and also providing fresh fruit, vegetables and meat, in addition to canned goods; At the time of this hearing there are four active Off-Sale licenses in Census Tract 5743. Since 2007, five businesses have operated with an off-sale license. If this CUP was granted the number of alcohol establishments would be five, the same the area has been for many years. Approval of this CUP would not increase the number of licenses that have operated in this census tract.

Due to the large size of the census tract it has a large number of reported crimes. However, this tract is twice as large as all the surrounding tracts and if it were the same size it would have just as low number of incidents as the neighboring census tracts do. Officers Miles and Neely, have patrolled the subject site and the surrounding area for many years. Both officers state that in reality, the property of 6370 E. Stearns Street and the surrounding area are in fact low crime areas. Further proof of this is that for years the area in question has only been patrolled by one police car during a shift. Areas that are really high crime such as the Eastside neighborhood have several cars patrolling the area during a single shift. As a result of this information, it is fair and reasonable for the Commission to determine that this area is not a high crime area and grant a waiver of this requirement.

- E. The use shall not be located within five hundred feet (500') of a public school, or public park, except: (1) locations in the greater downtown area; or (2) stores of more than twenty thousand (20,000) square feet of floor area, and also providing fresh fruit, vegetables and meat in addition to canned goods. The subject site is not within 500 feet of a public school or public park. Therefore, this finding is satisfied.

To whom it may Concern:

I am filing this letter in support Of the Circle K gas station located on the corner of Stearns and Palo Verde in the City of Long Beach. It is my understanding that there is a concern of over saturation of liquor licenses in the area that might contribute to at higher than normal crime rate. I disagree with those findings.

I must state that I have worked in the Law Enforcement community that services that area for over 30 years. It is my opinion that the subject site as well as the surrounding areas are some of the safest areas within city limits.

This area is a residential area that is quite a distance north of California State University Long Beach and, nowhere close to any surrounding schools. I must also state that I'm not aware of any high crime statistics or calls for service in the area that will be jeopardized by issuing a liquor license for this establishment.

Furthermore, I would add that this family has been business owners in this area for quite some time. To my knowledge, this family has not been cited for any illegal or unethical behavior and this establishment has not been known for any scrupulous business activities.

Therefore, it is in my professional opinion that the requested beer and wine license should be granted. Another note, much of the financing for the renovation of this convenience store and service station has been handled by the current business owners themselves, that is a testament to their commitment to this community. I believe that this would be a win for the community and the surrounding businesses.


