Subject:	City of Long Beach Loan Programs for Local Businesses

In March 2001, the City Council authorized an application to the Economic Development Administration (EDA) for \$1 million in grant funds to establish a Revolving Loan Fund (RLF) to benefit small and minority-owned businesses in Long Beach. The City has since used RLF to assist start-up and existing businesses to access low interest loans that may not be available to them through traditional commercial banks.

In recent years, the City has expanded its partnership with various business and community partners namely the Small Business Development Center (SBDC), National Development Council (NDC), and local banks to develop effective tools for economic development planning, coordination, cooperation, and easy access to conventional loans. Additionally, the has City expanded its partnership, with Long Beach City College to provide access to capital for eligible candidates participating in the Goldman Sachs 10,000 Small Business initiative.

Over the past 20 years, the City has provided access to capital for more than 100 businesses for a total of \$15 million in low-interest loans resulting in retention and creation of 400 plus jobs (Attachment A). Most recently, the City Council sponsored the creation of the Kiva microloan program to offer zero-percent interest, no-fee loans up to \$10,000. The following is a summary of loan programs offered in Long Beach:

Kiva Loan Program

- Partnership between the City of Long Beach and the Los Angeles Local Initiatives Support Corporation (LA LISC)
- 0 percent interest with up to 36-month repayment period
- Borrow between \$500 and \$10,000 through a crowd-funded loan program
- LA LISC will match loan contributions made to Long Beach-based businesses who have been endorsed by a Trustee

Microenterprise Loan Program

- Starts at \$25,000 for startup and existing businesses with five or fewer employees
- Fixed rate: prime rate plus 1.5 percent
- Funds can be used to finance equipment, fixtures and furniture, and working capital
- Borrower must create one full-time job for every \$35,000 borrowed

Grow Long Beach Fund

- Partnership between the City of Long Beach and NDC Grow America Fund
- Between \$100,000 to \$2 million available for businesses that have been operating in Long Beach for at least two years
- Fixed rate: based on current prime rate
- Term: 3 to 25 years
- Loans underwritten by NDC and guaranteed by the Small Business Administration
- Business must be a for-profit entity
- Funds can be used for any legitimate business expense (construction, tenant improvements, equipment, working capital, etc.)

Next Steps

Consistent with goals outlined in the City's Blueprint for Economic Development, the City continues to seek creative ways to expand access to capital for under-represented entrepreneurs. Staff is currently working with EDA to secure a \$2 million grant to augment the City's current microenterprise loan pool. The additional funds must be matched by local dollars, but will allow the City to increase its lending capacity in the years ahead.
