ORDINANCE NO.

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AMENDING THE LONG BEACH MUNICIPAL CODE BY ADDING SECTION 8.68.085 RELATING TO SMOKING PROHIBITED AT FARMERS' MARKETS

The City Council of the City of Long Beach ordains as follows:

Section 1. Section 8.68.085 is added to the Long Beach Municipal Code to read as follows:

8.68.085 Smoking prohibited – Farmers' markets.

Smoking is prohibited and is unlawful at any farmers' market and within twenty feet (20') of all entrances and exits of farmers' markets, as defined in Subsection 3.80.180.G. of the Long Beach Municipal Code.

Section 2. The City Clerk shall certify to the passage of this ordinance by the City Council and cause it to be posted in three (3) conspicuous places in the City of Long Beach, and it shall take effect on the thirty-first (31st) day after it is approved by the Mayor.
