FOURTH AMENDMENT TO AGREEMENT NO. 34316

THIS FOURTH AMENDMENT TO AGREEMENT NO. 34316 is made and entered, in duplicate, as of November 7, 2018, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on October 3, 2017, by and between MACIAS GINI & O'CONNELL LLP, a California limited liability partnership fka INTELLIBRIDGE PARTNERS LLC, a California limited liability company ("Consultant"), with a place of business at 3000 S Street, Suite 300, Sacramento, California 95816, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with as-needed professional and technical services; and

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 34316 (the "Agreement") whereby Consultant agreed to provide these services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to extend the term and increase the total not to exceed amount to \$400,000; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to increase the total not to exceed amount to \$800,000; and

WHEREAS, the Parties entered into a Third Amendment to the Agreement to increase the total not to exceed amount to \$1,200,000; and

WHEREAS, the Parties deesire to add \$400,000 for a total not to exceed amount of \$1,600,000;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 1.A of the Agreement is hereby amended to read as follows:

"A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, not to exceed One Million Six

Hundred Thousand Dollars (\$1,600,000), at the rates or charges shown in Exhibit "B"."

2. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 34316 are ratified and confirmed and shall remain in full force and effect.
