- Request staff to keep the registration fee to a minimum to encourage registration of STRs with the City.
- Request the CVB add STRs to their website and promotional materials when advertising options for conference attendees to find accommodations in Long Beach.
- Return to the City Council with additional information on how enforcement will be addressed in the ordinance, including information on whether a business license would be required and whether business license tax would be required.
- Staff to provide information on how funding for affordable housing would be provided as part of the STR ordinance or inclusionary housing ordinance.

#### **Accepted friendly amendments:**

• Include in the ordinance the ability for neighborhoods to ban un-hosted STRs with a 2/3rd vote of property owners, subject to

staff recommendations of a best-practice review and ideas to allow neighborhood petitions, while not unduly restricting the ability for un-hosted STRs to be located in and around the coastal zone.

- By October 2019, return to the City Council with information available on the number of registrations, number of complaints, resolutions to complaints, TOT tax collected and other relevant information to assess implementation for potential improvements and an annual review thereafter of the data once the ordinance has taken effect.
