3 AN ORDINANCE OF THE CITY COUNCIL OF THE
4 CITY OF LONG BEACH AMENDING THE LONG BEACH
5 MUNICIPAL CODE BY ADDING CHAPTER 1.15, AND BY
6 REPEALING SECTIONS 2.01.210(B) AND 2.01.1010; ALL
7 RELATING TO CHANGING THE REGULAR ELECTION
8 DATES OF THE PRIMARY NOMINATING AND GENERAL
9 MUNICIPAL ELECTIONS TO MARCH AND NOVEMBER,
10 RESPECTIVELY, TO COINCIDE WITH STATEWIDE
11 ELECTIONS AS REQUIRED BY SB 415

13 WHEREAS, the City of Long Beach, California ("City") is a municipal
14 corporation and charter city, duly organized under the Constitution and laws of the State
15 of California; and

16 WHEREAS, the California Voter Participation Rights Act (SB 415, codified
17 as Elections Code §§ 14050-14057), effective January 1, 2018, prohibits a public agency,
18 including a charter city, from holding its regular election on any date other than a
19 statewide election date if holding the election on a non-statewide election date results in
20 a "significant decrease in voter turnout," which is defined as at least 25 percent (25%)
21 less than the average voter turnout within the public agency for the previous four (4)
22 statewide general elections; and

23 WHEREAS, pursuant to City Charter sections 1901 and 2206, the City and
24 the Long Beach Unified School District currently hold their primary election on the second
25 Tuesday in April in even-numbered years, and their general municipal election on the first
26 Tuesday after the first Monday in June in even-numbered years; and

27 WHEREAS, the California Attorney General has opined that SB 415
28 prevails over conflicting Charter provisions, rendering the City's current Charter

1 provisions related to election dates void, allowing the City Council to change the
2 Charter's election dates without a Charter amendment in order to comply with SB 415;
3 and

4 WHEREAS, the City's primary election date is not a statewide election date
5 and voter turnout in local Long Beach Municipal elections has been at least 25 percent
6 (25%) less than the voter turnout for the previous four (4) statewide general elections;
7 and

8 WHEREAS, the general municipal election cannot be held on the same
9 date as the primary election and thus will also be required to change; and

10 WHEREAS, SB 568 requires the statewide primary election to be held on
11 the first Tuesday after the first Monday in March, beginning in 2019; and

12 WHEREAS, State law allows a city to increase or decrease the terms of
13 current municipal officers on a one-time basis by up to twelve (12) months until their
14 successors are elected and qualified, in order to match their terms with a changed
15 regular election date; and

16 WHEREAS, on October 10, 2017, the City Council of the City of Long
17 Beach adopted Resolution No. RES-17-0117 and approved changing its primary and
18 general municipal election dates to the statewide general election dates, now in March
19 and November of even-numbered years, beginning in 2020, to increase voter turnout and
20 to ensure compliance with SB 415, and to achieve consolidation with the statewide
21 election dates no later than November 8, 2022; and

22 WHEREAS, the City Council also desires to make consistent corrections to
23 election dates, terms of office and other technical matters in the Long Beach Municipal
24 Code and to that end, has requested the City Attorney to draft and such present
25 ordinances to the City Council; and

26 WHEREAS, the Long Beach Unified School District has been consulted and
27 has approved of the plan to implement SB 415;

28 NOW, THEREFORE, the City Council of the City of Long Beach hereby

1 A. Beginning in 2020, candidates shall be nominated in March,
2 elected in November and assume office on the third Tuesday in December.

3 B. The terms of office for City Council members elected in the
4 2016 and 2018 elections shall be extended by five (5) months (July to
5 December) to match them with the new election cycle, as permitted by
6 California Elections Code section 10403.5(b).

7 The terms of office for Citywide officials (City Auditor, City Attorney,
8 City Prosecutor, Mayor) elected in the April or June, 2018 elections shall be
9 extended by five (5) months (July to December) to match them with the new
10 election cycle, as permitted by California Elections Code section 10404.5(g).

11 C. The terms of office for Long Beach Unified School District
12 members elected in the 2016 election shall be extended by five (5) months
13 (July to December) to match them with the new election cycle, as permitted
14 by California Elections Code section 10404.5(g).

15 D. Municipal officers elected to new terms in November, 2022
16 and in all future elections shall serve standard four-year terms.

17 1.15.030 Election cycle.

18 'Election Cycle' means that period commencing with January 1 of an
19 odd-numbered year and ending December 31 of the following year. For a
20 special election, the Election Cycle commences with the declaration of a
21 vacancy in an elective office and ends six (6) months after the special
22 election date

23 1.15.040 Campaign funds.

24 Any funds remaining to a candidate, or any controlled committee of
25 such candidate, ninety (90) days following the end of the Election Cycle,
26 during which such funds have been raised, shall be defined as "surplus
27 funds" and shall be disposed of only as provided in this Chapter. Funds
28 retained by a candidate and specifically earmarked for payment of

1 campaign expenses lawfully incurred during the Election Cycle need not be
2 included in surplus funds provided that such expense payment is made no
3 later than ninety (90) days after the end of the Election Cycle.

4 1.15.050 Notice.

5 Pursuant to Elections Code 10403.5(e), within thirty (30) days after
6 the ordinance becomes operative, the City elections official shall cause a
7 notice to be mailed to registered voters within the City limits.

8 1.15.060 Severability.

9 If any section, subdivision, paragraph, sentence, clause, or phrase in
10 this ordinance or any part thereof is for any reason held to be
11 unconstitutional or invalid or ineffective by any court of competent
12 jurisdiction, such decision shall not affect the validity or effectiveness of the
13 remaining portions of this ordinance or any part thereof. The City Council
14 hereby declares that it would have passed each section, subdivision,
15 paragraph, sentence, clause, or phrase thereof irrespective of the fact that
16 any one or more sections, subdivisions, paragraphs, sentences, clauses, or
17 phrases be declared unconstitutional, or invalid, or ineffective

18 1.15.070 CEQA.

19 This ordinance is exempt from the requirements of the California
20 Environmental Quality Act (CEQA) because it is not a project within the
21 meaning of 14 CCR § 15378 or alternatively, because it is covered by the
22 general rule that CEQA applies only to projects which the potential for
23 causing a significant effect on the environment (14 CCR § 15061(b)(3)).

24 This ordinance implements changes to the timing of municipal elections that
25 have no potential for direct or indirect changes to the environment.

27 Section 4. Sections 2.01.210(B) and 2.01.1010 of the Long Beach
28 Municipal Code are hereby repealed.
