

SUBJECT***Fiscal Year 2019 Second Quarter Investment Report*****BACKGROUND**


Under the provisions of section 53600 et seq. of the California Government Code, Long Beach Transit (LBT) is required to submit a quarterly report of its investment holdings to its Board of Directors.

Attached is the Quarterly Investment Report as of December 31, 2018. LBT's assets are held at the State's Local Agency Investment Fund (LAIF), City National Bank general account, Wells Fargo worker's compensation account and the Corporate Investment Account which contains investment vehicles similarly structured to LAIF.

The cash and investment balance as of December 31, 2018 increased by \$11,675,024 when compared to the prior quarter. The increase is primarily due to receipts of state funding (Transportation Development Act) totaling \$7.8 million as well as local funding (Prop A Discretionary 40%) totaling \$5 million.

The objectives in this financial market continue to be to preserve principal and maintain liquidity. Meeting these objectives require assuming less portfolio risk resulting in lower investment returns.

The \$74 million total cash and investment balance includes \$38.7 million in restricted funds. The restricted funds are designated for various capital grants and self-insurance programs. These funds are held until related expenditures are incurred.
