3 A RESOLUTION OF THE FINANCE AUTHORITY OF
4 LONG BEACH ESTABLISHING REGULAR MEETING

7 WHEREAS, the Finance Authority of Long Beach (the "Authority") is a joint
8 powers authority duly organized and existing pursuant to a Joint Exercise of Powers
9 Agreement (No. 34115) ("JPA Agreement"), dated December 8, 2015, by and between
10 the City of Long Beach (the "City") and the Housing Authority of the City of Long Beach;
11 and

12 WHEREAS, in order for the Board to provide approval of the issuance of
13 future bonds and amendments to existing bonds, it is necessary to set a regular meeting
14 date for the Authority as required by California Government Code Section 6592.1;

15 NOW, THEREFORE, the Board of Directors of the Finance Authority of
16 Long Beach resolves as follows:

17 Section 1. Regular Meeting Dates. The Authority hereby affirms the
18 second Monday of October as the regular meeting date of the Authority, as provided in
19 the JPA Agreement. In addition to the aforementioned regular meeting date, the
20 Authority hereby establishes February 25, 2019, as a regular meeting date of the
21 Authority, with such meeting to be held at 9:00 a.m. in the Council Chambers, in the Long
22 Beach City Hall, 333 West Ocean Street, Long Beach, California. Notwithstanding the
23 foregoing, if there are no matters for the Board to consider at any such regular meeting,
24 such regular meeting may be cancelled. The foregoing establishment of regular meeting
25 dates shall not preclude the calling by the Board of special meetings of the Authority, or
26 preclude the Board from adopting additional regular meeting dates of the Authority.

27 Section 2. Effective Date. This resolution shall take effect from and after
