## RESOLUTION NO. RES-19-0026

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH HAAKER EQUIPMENT COMPANY TO PURCHASE ELEVEN CNG-POWERED STREET SWEEPERS, THROUGH THEIR CONTRACT WITH SOURCEWELL (FORMERLY THE NATIONAL JOINT POWERS ALLIANCE) IN AN AMOUNT NOT TO EXCEED \$4,377,361, INCLUDING TAXES AND FEES

WHEREAS, the Charter of the City of Long Beach (the "City"), Section 1802, permits the City to purchase services, supplies, materials, equipment and labor with other government agencies by purchasing under their contracts on a voluntary and selective basis when authorized by resolution; and

WHEREAS, the City desires to purchase eleven (11) CNG-powered Street Sweepers, with related equipment and accessories ("Street Sweepers"); and

WHEREAS, Sourcewell (formerly the National Joint Powers Alliance) has a Contract with HAAKER EQUIPMENT COMPANY ("Haaker") for the purchase of these Street Sweepers, Contract No. 122017-FSC ("Sourcewell Contract"); and

WHEREAS, the City's participation in the Sourcewell Contract will facilitate the City's ability to purchase these Street Sweepers as well as provide considerable cost benefits to the City; and

WHEREAS, if the City had to utilize a formal bid process rather than participate in the Sourcewell Contract considerably more funds would be required;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as

10	Dollars (\$4,377,361) including taxes and fees.
