9 Pursuant to and in accordance with the provisions of Section Section 1. 10 34090 of the Government Code of the State of California and Chapter 1.28 of the Long 11 Beach Municipal Code relating to the destruction of City records, and the City Attorney 12 having heretofore given his written consent, the City Council of the City of Long Beach 13 does hereby approve and authorize the destruction by the Police Department of any and 14 all of the records, documents, instruments, books, papers, and writings as set forth in the 15 documents attached hereto and marked Exhibit "A" and by reference thereto made a part hereof, which records are under its charge and are no longer required for use in its respective office, said records being no less than two (2) years old.


