 - It is important to note that the City departments spearheading these efforts, especially Parks and Recreation and the Pacific Gateway Workforce Innovation Network (PGWIN), need to partner with community-based organizations to effectively serve the populations who are most in need of workforce-development services.
 - There is a coalition of nonprofit and community-based organizations, including California Immigrant Policy Center, Centro CHA, Green Education Inc., GRID Alternatives - Greater Los Angeles, Long Beach Coalition for Good Jobs and a Healthy Community, Long Beach Community Action Partnership, Long Beach Forward, Long Beach Immigrant Rights Coalition, and United Cambodian Community, who are advocating for PGWIN to be more inclusive in its meetings and planning processes; adequately fund CBOs to provide job training, mentoring, and case management to communities with barriers to employment; create realistic performance measures that prioritize those most in need, not just those most likely to succeed; implement PGWIN's language-access policy with an accountability plan to report progress to its board bi-annually; and reduce transportation as a barrier to accessing services. This proposal partially addresses the transportation barriers that some face in accessing workforce-development support. Community-based organizations with experience working with those who face barriers to employment should also be considered as potential satellite sites for workforce services.
 - o As this strategy is developed, we encourage the City to partner with community-based organizations in its design and implementation.
- <u>Connectedness (Economic Resilience)</u>: Support the Establishment of a Community Development Corporation (CDC) to deploy programs and services that support the economic development and financial empowerment of North, Central, and West Long Beach communities.

United Cambodian Community (UCC) supports the 'Everyone In' Long Beach Economic Inclusion Plan proposed in agenda item 32, coming before Council on June 11, 2019. The proposed policy will promote a more economically equitable city that invests in community members that historically have not gain access to economic opportunities.

After 40 years since Cambodian refugees immigrated to Long Beach, the Cambodian community continues to have high rates of poverty. Over 33% of Cambodians living in Cambodia Town are in poverty. Additionally, only 25% of Cambodians own a home. Southeast Asian women are the second highest population that are rent burden, paying over one third of their income to rent. Due to the economic needs, UCC seeks to elevate the Cambodian community through local leadership and engagement that embodies Cambodian cultural values. We do this through economic inclusion, health equity, community integration, and youth enrichment. UCC addresses Cambodian community through small business supports, EL workforce development, and housing counseling. UCC's work aligns with the strategies described in the Economic Inclusion plan, so we are in support of the following strategies and express the following recommendations:
