RESOLUTION NO. RES-19-0101

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH, CALIFORNIA, REQUESTING THE BOARD OF SUPERVISORS OF THE COUNTY OF LOS ANGELES TO RENDER SPECIFIED SERVICES TO THE CITY RELATING TO THE CONDUCT OF A SPECIAL MUNICIPAL ELECTION TO BE HELD ON TUESDAY, NOVEMBER 5, 2019

WHEREAS, a Special Municipal Election is to be held in the City of Long Beach, California on November 5, 2019; and

WHEREAS, in the course of conduct of this election, it will be necessary for the City to request services of the County; and

WHEREAS, all necessary expenses in performing this service shall be paid by the City of Long Beach;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:

Section 1. That pursuant to the provisions of Section 10002 of the Elections Code of the State of California, the City Council requests the Board of Supervisors of the County to permit the Los Angeles County Registrar-Recorder/County Clerk to prepare and furnish full election services for use in conducting the election. These services include, but are not limited to:

A. A listing of County precincts with number of registered voters in each, so City may consolidate election precincts into City voting precincts, and maps of the voting precincts;

B. A list of polling places and poll workers the County uses for their elections;

1 C. The computer record of the names and addresses of all
2 eligible registered voters in the City in order that the County's consultant
3 may:

- 4 1. Produce labels for vote by mail voters;
5 2. Produce labels for sample ballot pamphlets; and
6 3. Print rosters of voters and street indexes.

7 D. Voter signature verification services as needed; and

8 E. Make available to the City election equipment and assistance
9 as needed according to state law.

10 Section 2. That the City shall reimburse the County for services
11 performed when the work is completed and upon presentation to the City of a properly
12 approved bill.

13 Section 3. That the City Clerk is hereby directed to forward without delay
14 to the Board of Supervisors and to the Los Angeles County Registrar-Recorder/County
15 Clerk a certified copy of this resolution.

16 Section 4. This resolution shall take effect immediately upon its adoption
17 by the City Council, and the City Clerk shall certify the vote adopting this resolution.


