A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT WITH LOS ANGELES TRUCK CENTERS, LLC, WITHOUT ADVERTISING FOR BIDS, FOR THE PURCHASE OF STERLING AND AUTOCAR PARTS FOR A PERIOD OF TWO YEARS WITH OPTION TO RENEW FOR THREE ADDITIONAL ONE-YEAR PERIODS IN AN ANNUAL AMOUNT NOT TO EXCEED \$184,000

WHEREAS, there are currently sixty-two (62) Sterling and Autocar units ("Units") in the City fleet that require replacement parts; and

WHEREAS, the Fleet Services Bureau maintains and repairs these Units as part of the City's fleet maintenance program; and

WHEREAS, Los Angeles Truck Center, LLC is the only authorized Sterling and Autocar parts distributor in Southern California; and

WHEREAS, no useful purpose would be served by advertising for bids and to do so would constitute an idle and useless act and an unnecessary expenditure of public funds because Los Angeles Truck Center, LLC is the only corporation, firm or individual that could or would bid for the as-needed Sterling and Autocar replacement parts;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:

Section 1. The City Manager is hereby authorized to enter a contract with Los Angeles Truck Centers, LLC without advertising for bids to provide Sterling and Autocar parts in an annual amount not to exceed One Hundred Eighty-Four Thousand
