AN ORDINANCE OF THE CITY COUNCIL OF THE  
CITY OF LONG BEACH AMENDING THE LONG BEACH  
MUNICIPAL CODE BY ADDING SUBSECTIONS  
10.14.020.A.118 AND 10.14.020.A.119 RELATING TO  
ONE-WAY STREETS AND ALLEYS

The City Council of the City of Long Beach ordains as follows:

Section 1. Subsection 10.14.020.A.118 is added to the Long Beach  
Municipal Code to read as follows:

118. (North) Norman Court, between 10th Street and 11th Street.

Section 2. Subsection 10.14.020.A.119 is added to the Long Beach  
Municipal Code to read as follows:

119. (South) Almond Court, between 10th Street and 11th Street.

Section 3. The City Clerk shall certify to the passage of this ordinance  
by the City Council and cause it to be posted in three (3) conspicuous places in the City  
of Long Beach, and it shall take effect on the thirty-first (31st) day after it is approved by  
the Mayor.
