THIRD AMENDMENT TO AGREEMENT NO. 33580

THIS THIRD AMENDMENT TO AGREEMENT NO. 33580 is made and entered, in duplicate, as of July 24, 2019, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on July 16, 2019, by and between SIMPLER SYSTEMS, INC., a California corporation ("Consultant"), with a place of business at 210 West Cota Street, Santa Barbara, California 93101, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 33580 (the "Agreement") whereby Consultant agreed to provide services in connection with maintenance of the City's Financial Accounting Information System; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to extend the term and add \$150,000; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to extend the term to September 18, 2018 and add \$150,000 for a total not to exceed amount of \$600,000; and

WHEREAS, the Parties desire to extend the term one (1) additional twoyear period, add the \$150,000 annual amount, and update the City's Notice address;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 1.A. of the Agreement is hereby amended to read as follows:
- "A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to the Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, in a total amount not to exceed Nine Hundred Thousand Dollars (\$900,000) at the rates or charges shown in Exhibit "A"."
 - 2. Section 2 of the Agreement is hereby amended to read as follows:

- "22. <u>NOTICES</u>. Any notice or approval required by this Agreement shall be in writing and personally delivered or deposited in the U.S. Postal Service, first class, postage prepaid, addressed to Consultant at the address first stated above, and to City at 411 West Ocean Boulevard, Long Beach, California 90802, Attn: City Manager. Notice of change of address shall be given in the same manner as stated for other notices. Notice shall be deemed given on the date deposited in the mail or on the date personal delivery is made, whichever occurs first."
- 4. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 33580 are ratified and confirmed and shall remain in full force and effect.
