WHEREAS, the City desires to purchase a MC-502 Skimmer Boat ("Boat") with related equipment and accessories for the Parks, Recreation and Marine Department (PRM) Beach Maintenance Division; and

WHEREAS, the Boat is designed to remove debris from the harbors, marinas and open waterways; and

WHEREAS, the Boat can skim within the "set" debris booms to remove smaller floating surface debris found along the Rainbow Harbor and Shoreline Marina areas; and

WHEREAS, Barber Welding, Inc. is the manufacturer and sole distributor for specialized equipment of this type; and

WHEREAS, several different types of skimmer boats were examined to use for debris collection operations and the Boat was found to be the most efficient and practical by the Parks, Recreation, and Marine Department; and

WHEREAS, as a result, no useful purpose would be served by advertising for bids and to do so would constitute an idle and useless act and an unnecessary expenditure of public funds;
