RECOMMENDATION:

That the City Council adopt a resolution designating the ballot listing of the candidates which have been duly nominated for the City's Special Municipal Election on Tuesday, November 5, 2019. (District One)

DISCUSSION

On July 9, 2019, the City Council adopted a resolution declaring a vacancy, calling and giving notice of the Special Municipal Election to fill the vacant seat in Council District One.

With the close of the candidate nomination period on August 9, 2019, the City Clerk is required to submit the attached resolution for adoption pursuant to City Charter Section 1907, which serves to certify the list of candidates who were duly nominated, and identify the order in which their names will appear on the official ballot.

TIMING CONSIDERATIONS

Approval of the recommended action at this time will allow the Los Angeles Registrar-Recorder/County Clerk to prepare the official ballot, sample ballot and ballot pamphlet.

FISCAL IMPACT

The Office of the City Clerk budget contains the appropriations necessary to conduct the November 5, 2019 Special Municipal Election.

RE: November 5, 2019, Elections: Randomized Alphabet Drawing

In accordance with Elections Code section 13112(b)(1)(F), the Secretary of State's office conducted a drawing of the letters of the alphabet to determine the randomized alphabet for use in the above election. Listed below is the official order of letters for use in determining placement of candidates' names on the ballot.

Please note that this alphabet is to be applied THROUGHOUT the candidate's entire last name, so if more than one candidate's surname begins with the same letter, the second letter of the surname determines who goes first, according to where the second letter of the name appears in the random alphabet. For example, if two candidates with the surname of Campbell and Carlson are running for the same office, their order on the ballot will depend on the order in which the letters "M " and "R" were drawn in the randomized alphabet drawing.

A RESOLUTION OF THE CITY COUNCIL OF THE
CITY OF LONG BEACH DESIGNATING THE BALLOT
LISTING OF THE CANDIDATES WHICH HAVE BEEN
NOMINATED FOR THE CITY'S SPECIAL MUNICIPAL
ELECTION ON TUESDAY, NOVEMBER 5, 2019

WHEREAS, in accordance with the Long Beach City Charter, the City
Council has called a Special Municipal Election to be held in the City of Long Beach on
November 5, 2019, for the City Council office in Council District One; and

WHEREAS, in accordance with City Charter Section 1907, the City Clerk
has submitted to the City Council a certified list of the candidates which have been duly
nominated as required by law for the elective office to be voted on at said election, and
the names are listed for the office in the order of the randomized alphabet selected by the
Secretary of State in a drawing held on August 15, 2019, pursuant to California Elections
Code Section 13112;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as
follows:

Section 1. That the following list which has been regularly certified by the
City Clerk sets forth the candidates nominated as required by law for the office shown
and is in the order of the randomized alphabet selected by the California Secretary of
State:

9 Section 2. The City Clerk shall cause the list of nominees to be published
10 in accordance with California Elections Code Section 12110 and California government
11 code Section 6061.

12 Section 3. This resolution shall take effect immediately upon its adoption
13 by the City Council, and the City Clerk shall certify the vote adopting this resolution.
