

FOURTH AMENDMENT TO AGREEMENT NO. 33509

THIS FOURTH AMENDMENT TO AGREEMENT NO. 33509 is made and entered, in duplicate, as of July 26, 2019, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting only June 13, 2017, by and between MOORE IACOFANO GOLTSMAN, INC., a California corporation DBA MIG, ~~CALVIN R. ABE & ASSOCIATES, INC. DBA AHBE LANDSCAPE ARCHITECTS~~, a California corporation with a place of business at 617 West 7th Street, and for MIG's Los Angeles operation located ~~and DBA AHBE/MIG~~ Suite 304, Los Angeles, California 90017 ("Consultant"), and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 33509 (the "Agreement") whereby Consultant agreed to provide as-needed landscape architectural services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to extend the term and add \$200,000 for a total not to exceed amount of \$450,000; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to extend the term and add \$100,000 for a total not to exceed amount of \$550,000; and

WHEREAS, the Parties entered into a Third Amendment to the Agreement to extend the term update the City Representative; and

WHEREAS, the Parties desire to extend the term one (1) additional one-year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 2 of the Agreement is hereby amended to read as follows:

"2. TERM. The term of this Agreement shall commence at midnight on August 1, 2014, and shall terminate at 11:59 p.m. on August 1, 2020, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner."




