Adopt Resolution WD-1417 Authorizing the General Manager to enter into a Purchase Order Agreement with CDWG under the purchase conditions specified in the OMNIA Public Sector partners (previously known as the TCPN Cooperative Purchasing Network Agreement) contract for the purchase of computer equipment to cumulatively not exceed \$200,000 per year, subject to two (1) year renewals at the discretion of the General Manager.

Executive Summary:

The Long Beach City Charter provides an alternative procurement method by permitting the Water Department to purchase or otherwise obtain services, supplies, materials, equipment and labor with other governmental agencies by purchasing under their contracts on a voluntary and selective basis when authorized by a Resolution of the Board of Water Commissioners. The Water Department requires the purchase of computer equipment on an as needed basis for PC replacements, network switch replacements, application server upgrades, file server upgrades, and the installation of a security enforced wireless network to be installed at the Treatment Plant and Administration Building.

Recommendations:

Adopt Resolution WD-1417 Authorizing the General Manager to enter into a Purchase Order Agreement with CDWG under the purchase conditions specified in the OMNIA Public Sector partners (previously known as the TCPN Cooperative Purchasing Network Agreement) contract for the purchase of computer equipment to cumulatively not exceed \$200,000 per year, subject to two (1) year renewals at the discretion of the General Manager.

Fiscal Impact: Funding for the purchases has been included in the FY 2020 Water Department budget and have been included in financial projections. By not participating in the OMNIA purchasing cooperative the Water department could incur additional computer equipment procurement costs and shipping times by bidding out the technology specification.

A RESOLUTION OF THE BOARD OF WATER COMMISSIONERS OF THE CITY OF LONG BEACH AUTHORIZING THE GENERAL MANAGER TO ENTER INTO PURCHASE ORDER AGREEMENT WITH CDW GOVERNMENT LLC FOR AS-NEEDED COMPUTER EQUIPMENT, ON THE SAME TERMS AND CONDITIONS AFFORDED TO REGION 4 EDUCATION SERVICE CENTER THROUGH OMNIA PARTNERS, FORMERLY KNOWN AS THE COOPERATIVE PURCHASING NETWORK

WHEREAS, the Charter of the City of Long Beach, Section 1802, permits the Board of Water Commissioners ("Board") to purchase services, supplies, materials, equipment, and labor with other government agencies by purchasing under their contracts on a voluntary and selective basis when authorized by resolution; and

WHEREAS, the Water Department requires computer equipment on an asneeded basis; and

WHEREAS, the Region 4 Education Service Center through Omnia Partners, formerly known as The Cooperative Purchasing Network ("TCPN") has a contract with CDW Government LLC for the purchase of technology and interactive whiteboard solutions products and services, TCPN Contract No. R160201 ("TCPN Contract"); and

WHEREAS, the TCPN Contract was competitively bid in accordance with public contracting procedures; and

WHEREAS, the Board's participation in the TCPN Contract will facilitate acquisition of as-needed computer equipment as well as provide considerable cost benefits to the Board; and

WHEREAS, if the Board had to go to formal bid rather than participate in the
