

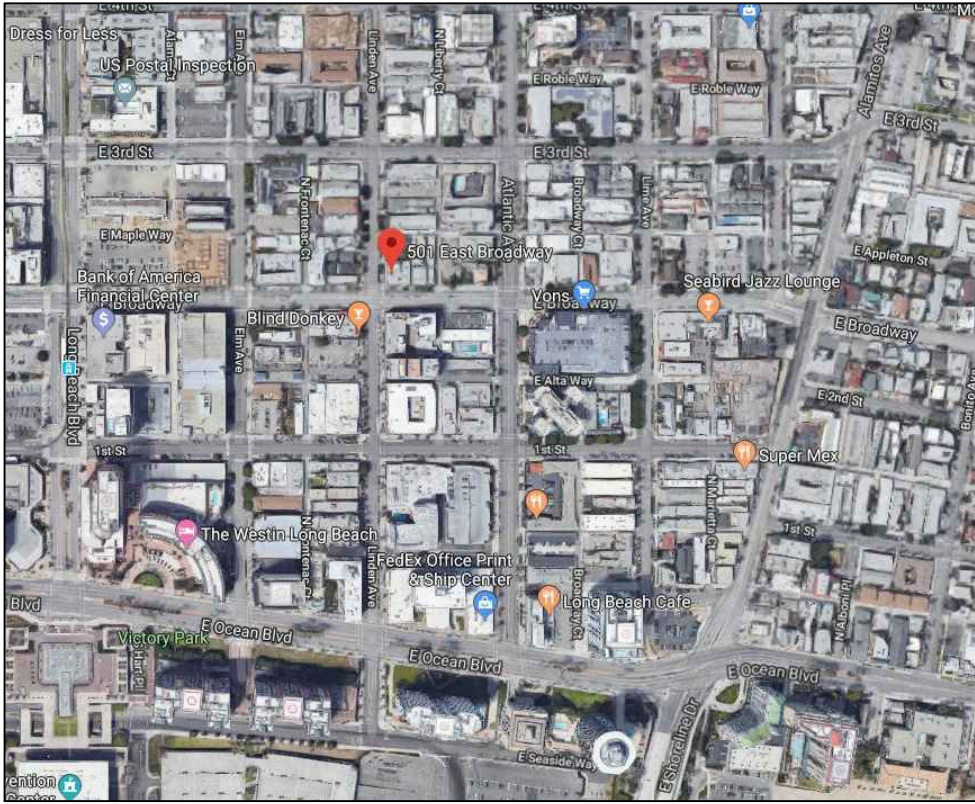
GENERAL NOTES :

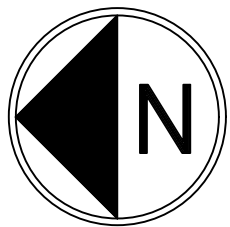


(E)ROOF OVER

PROPOSED (WEST) RIGHT SIDE ELEVATION 4

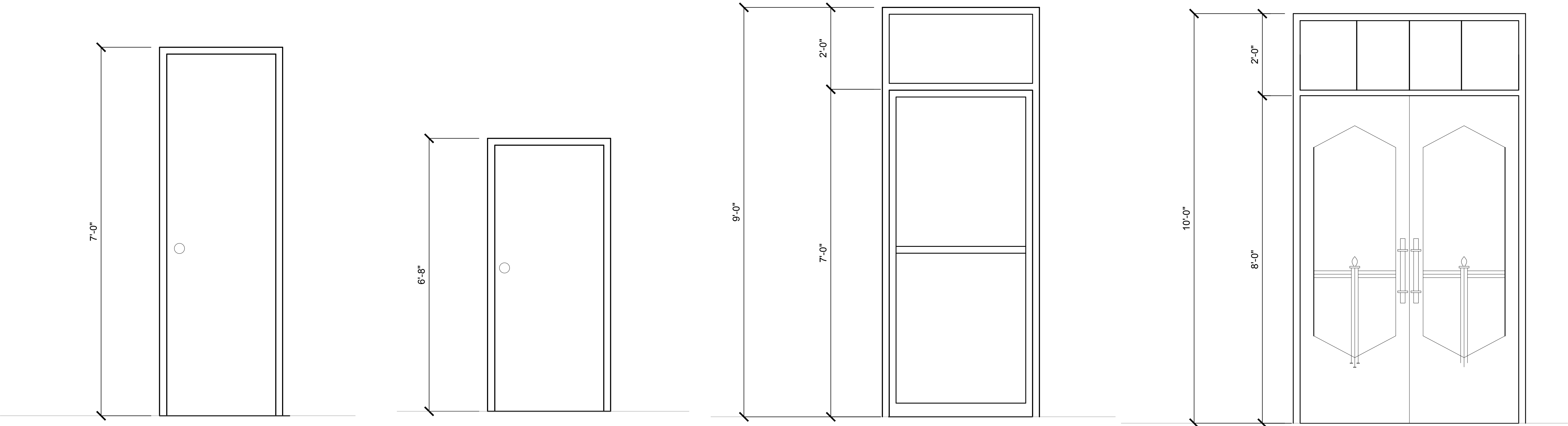
