This memorandum was written to provide historical perspective on the use of flex cuffs by the Long Beach Police Department. Flex Cuffs are a type of disposable restraint specifically designed by the manufacturer to meet law enforcement security and tactical requirements. They are different from the standard "zip tie" sold in hardware stores.

The Long Beach Police Department's SWAT team uses flex cuffs because team members do not typically transport or book their own prisoners. This makes the retrieval of a standard metal handcuff difficult once they are loaned to another officer for transport of an arrestee. In addition, SWAT officers routinely handcuff multiple subjects and need to carry more than two pairs of handcuffs. Flex cuffs are lightweight, easier to store, and can be placed into a tactical entry vest without using any significant storage space or pouches.

Flex cuffs are additionally used throughout the Police Department during mobile field force applications for the same reasons as SWAT. Flex cuffs are disposable, lightweight, and can be carried by an officer in larger quantities for subsequent application, as needed.

The Long Beach Police Department's SWAT team currently uses a flex cuff manufactured by The Safariland Group. Per the manufacturer's guidelines, the flex cuffs are designed to be used with the standard cuffing technique, are ½" wide, and have a tensile strength of 400 lbs. The flex cuffs can be removed using an EMT (Emergency Medical Technician) sheer which is carried by all Emergency Medical Technicians on the SWAT team. The SWAT team has additional medical / EMT sheers available, and ready for use, by officers to safely remove flex cuffs from arrestees when applicable.

In addition, the Long Beach Police Department has identified a tool specific for the removal of flex cuffs. The item is identified as "Galls Cuff Cutters" and are being made available for police officers to use when applicable. For further details, see photo attachment.

The objective standard for the use of flex cuffs falls under the same policy governing the use of metal handcuffs in the Long Beach Police Department Manual. Furthermore, the length of time a flex cuff remains on a subject, or how tight a flex cuff should be, falls under the same objective standard consistent with the use of metal handcuffs.


