- "2. <u>TERM</u>. The term of this Agreement shall commence at midnight on June 1, 2015, and shall terminate at 11:59 p.m. on May 31, 2020, unless sooner terminated or extended as provided in this Agreement, or unless the services are completed sooner."
- 2. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 33882 are ratified and confirmed and shall remain in full force and effect.
