Exhibit J: Updates and Corrections to LUE and UDE Plan Texts

This Exhibit provides an overview of and tracks changes to the Land Use Element (LUE) and Urban Design Element (UDE) plan texts since the 2016 EIR was circulated. PlaceType and Height maps, consistent with the March 6, 2018 action of the City Council ("Final Maps"), were prepared and posted on the City's web site in March 2018. Subsequently, maps throughout the LUE and UDE have been revised to be consistent with those changes. Additionally, the map changes necessitated changes to the plan texts to similarly make all texts and maps consistent with each other. Other updates were made to address environmental impacts arising from the environmental review process.

March 2018 to June 2019 – Planning Commission and City Council Approved Policy Revisions

As described on pages 3-15 to 3-16 of the Recirculated EIR, several policies were amended or added from the 2016 LUE and UDE to the 2018 LUE and UDE. Many of the changes were technical fixes, clarifications, or new policies requested by various stakeholders throughout the 2017 community engagement process that were approved by the Planning Commission and City Council in their actions on December 11, 2017 and March 6, 2018, respectively. Where applicable, these updated and/or new policies were added to relevant sections of the Recirculated Draft EIR. The following list summarizes the policy changes that were implemented:

- At the request of community members, several new policies were added around environmental justice and equity, including stronger language around Green Zones and policies facilitating collaboration with the City's Office of Equity.
- At the request of community members, policies were added to promote sustainable design and planning practices.
- At the request of community members, a policy was added to locate schools and other sensitive receptors at least 500 ft away from freeways when feasible.
- At the request of a local US Navy contact, policies were added to better ensure collaboration between the City and the Seal Beach U.S. Naval Weapons Station.
- Policies were added to better strengthen the City's fiscal health and align economic development.
- Policies were added to reflect the City's intent to support development and preservation of affordable housing.
- Policies were added to promote and accommodate all modes of travel and reduce Vehicle Miles Traveled (VMT), in accordance with the State's guidelines.
- Policies were added to strengthen and improve the City's current practice of coordinating and consulting with Native American Tribes during the planning process.
- Policies were added that focus on community needs and resources for students.
- Policies were added to create incentives for grocery store development.
- Policies were added related to natural resource protection.
- A policy was added to address nuisance motels in over-concentrated areas.
- In addition, implementation programs were added to support new policies and strengthen policy direction.

2019 - Technical Modifications and Minor Corrections

Technical modifications and minor corrections were made to the LUE and UDE texts as the recirculated EIR was finalized and after its publication. These updates were made to address issues raised through the environmental review process, as well as to address errors or typos; to bring the document up-to-date; to fill gaps in missing information; and to ensure compliance with state law. These changes are tracked in the table below.
