3 THIS THIRTEENTH AMENDMENT TO AGREEMENT NO. 33392 is made
4 and entered, in duplicate, as of October 24, 2019, for reference purposes only, pursuant to
5 a minute order adopted by the City Council of the City of Long Beach at its meeting on
6 October 15, 2019, by and between THE RYTE PROFESSIONALS, a corporation
7 ("Consultant"), with a place of business at 4141 Ball Road, #517, Cypress, California
8 90630, and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.
10 33392 (the "Agreement") whereby Consultant agreed to provide professional and technical
11 services for information technology projects and systems on an as-needed basis; and

12 WHEREAS, the Parties entered into a First Amendment to the Agreement to
13 increase the not to exceed amount to \$100,000; and

14 WHEREAS, the Parties entered into a Second Amendment to the Agreement
15 to increase the not to exceed amount to \$200,000; and

16 WHEREAS, the Parties entered into a Third Amendment to the Agreement
17 to increase the not to exceed amount to \$400,000 and extend the term to January 22,
18 2017; and

19 WHEREAS, the Parties entered into a Fourth Amendment to the Agreement
20 to increase the not to exceed amount to \$600,000; and

21 WHEREAS, the Parties entered into a Fifth Amendment to the Agreement to
22 increase the not to exceed amount to \$900,000; and

23 WHEREAS, the Parties entered into a Sixth Amendment to the Agreement
24 to increase the total not to exceed amount to \$1,500,000 and extend the term to January
25 22, 2018; and

26 WHEREAS, the Parties entered into a Seventh Amendment to the
27 Agreement to increase the total not to exceed amount to \$2,000,000; and

28 WHEREAS, the Parties entered into an Eighth Amendment to the Agreement

1 to increase the total not to exceed amount to \$3,000,000 and extend the term to January
2 22, 2019; and

3 WHEREAS, the Parties entered into a Ninth Amendment to the Agreement
4 to increase the total not to exceed amount to \$3,350,000 and extend the term to May 22,
5 2019; and

6 WHEREAS, the Parties entered into a Tenth Amendment to the Agreement
7 to increase the total not to exceed amount to \$4,500,000; and

8 WHEREAS, the Parties entered into an Eleventh Amendment to the
9 Agreement to increase the total not to exceed amount to \$5,000,000 and extend the term
10 to October 22, 2019; and

11 WHEREAS, the Parties entered into a Twelfth Amendment to the Agreement
12 to increase the total not to exceed amount to \$5,595,000; and

13 WHEREAS, the Parties desire to add \$405,000 to the Agreement for a total
14 not to exceed amount of \$6,000,000 and extend the term to March 22, 2020;

15 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
16 conditions herein contained, the Parties agree as follows:

17 1. Section 1.A of the Agreement is hereby amended to read as follows:

18 "A. Consultant shall furnish specialized services more particularly
19 described in Exhibit "A," attached to the Agreement and incorporated by this
20 reference, in accordance with the standards of the profession, and City shall pay
21 for these services in the manner described below, a total not to exceed contract
22 amount of Six Million Dollars (\$6,000,000), at the rates or charges shown in Exhibit
23 "A"."

24 2. Section 2. of the Agreement is hereby amended to read as follows:

25 "2. TERM. The term of this Agreement shall commence on January 22,
26 2014, and shall terminate on March 22, 2020, unless sooner terminated as provided in this
27 Agreement, or unless the services or the Project is completed sooner."

28 3. Except as expressly modified herein, all of the terms and conditions

1 contained in Agreement No. 33392 are ratified and confirmed and shall remain in full force
2 and effect.

3 IN WITNESS WHEREOF, the Parties have caused this document to be duly
4 executed with all formalities required by law as of the date first stated above.
