3 AN ORDINANCE OF THE CITY COUNCIL OF THE
4 CITY OF LONG BEACH AMENDING THE LONG BEACH
5 MUNICIPAL CODE BY AMENDING SECTION 3.80.420.5
6 RELATING TO SEPARATE LICENSE FOR EACH PLACE
7 OF BUSINESS

9 The City Council of the City of Long Beach does hereby ordain as follows:
10

11 Section 1. Section 3.80.420.5 of the Long Beach Municipal Code is
12 amended to read as follows:

13 3.80.420.5 Separate license for each place of business - Exception for booth
14 selling and independent contractors.

15 A. A separate license shall be obtained for each branch
16 establishment or separate office or place for carrying on any business or
17 pursuit within the City and the amount thereof, unless otherwise specified,
18 shall be equal to the amount specified for carrying on the original business
19 or pursuit.

20 B. Independent contractors licensed from multiple locations
21 within the City shall only pay a business license tax for one (1) location in
22 the amount specified for carrying on such business pursuit. Additional
23 locations within the City, for the same independent contractor, shall be
24 exempt from paying a business license tax.

25 C. This Section shall not be construed to require any existing
26 business licensed at a fixed location within the City to obtain an additional
27 license for conducting the same type of business at a different location as
28 booth selling, provided that any such business subject to the provisions of

Title 5 of this Code shall comply with all applicable requirements of that Title 5 and shall notify the Police Department of such booth selling.

Section 2. The City Clerk shall certify to the passage of this ordinance by the City Council and cause it to be posted in three (3) conspicuous places in the City of Long Beach, and it shall take effect on the thirty-first (31st) day after it is approved by the Mayor.
