ON THE SAME TERMS AND 7 CONDITIONS AFFORDED TO REGION 4 EDUCATION 8 SERVICE CENTER THROUGH OMNIA PARTNERS 9 10 WHEREAS, the Charter of the City of Long Beach (the "City"), Section 11 1802, permits the City to purchase services, supplies, materials, equipment and labor 12 with other government agencies by purchasing under their contracts on a voluntary and 13 selective basis when authorized by resolution; and 14 WHEREAS, the City desires to purchase custodial supplies; and 15 WHEREAS, the Region 4 Education Service Center through Omnia 16 Partners has a Contract with Office Depot, Inc. for the purchase of custodial supplies. 17 Contract No. R162102 ("Omnia Contract"); and 18 WHEREAS, the City's participation in the Omnia Contract will facilitate 19 acquisition of the custodial supplies as well as provide considerable cost benefits to the 20 City; and 21 WHEREAS, if the City had to go to formal bid rather than participate in the 22 Omnia Contract considerably more funds would be required; 23 NOW, THEREFORE, the City Council of the City of Long Beach resolves as 24 follows: 25 Section 1. The above recitals are true and correct and are incorporated 26 herein by this reference. 27 Section 2. The City Manager of the City is hereby authorized to enter an agreement with Office Depot, Inc., to purchase custodial supplies of substantially the 28 1

1 same type and kind purchased by the Regional 4 Education Service Center through 2 Omnia Partners pursuant to the Omnia Contract except as modified by mutual agreement 3 of the City and Office Depot, Inc., and the purchase by the City shall be on the same 4 terms and conditions afforded to the Regional 4 Education Service Center through Omnia 5 Partners in an annual amount of One Million Five Hundred Thousand Dollars 6 (\$1,500,000) including tax and shipping, until the Omnia Partners contract expires on 7 February 28, 2021, with the option to renew for as long as the Omnia Partners contract is 8 in effect, at the discretion of the City Manager.

9 Section 3. This resolution shall take effect immediately upon its adoption
10 by the City Council, and the City Clerk shall certify the vote adopting this resolution.
