Adopt Resolution No. WD-1420 authorizing the General Manager to enter into a sole source contract with Haaker Equipment Company for manufacturer authorized replacement parts and services, in an amount not to exceed \$150,000 for a one-year period and to exercise the option to renew for two (2) additional one-year periods.

Executive Summary:

The Long Beach City Charter provides an alternative procurement method by permitting the Board of Water Commissioners (Board) to obtain services without a traditional bidding procedure when authorized by a Resolution of the Board.

Haaker Equipment Company is the sole distributor of Envirosight camera systems, Vactor Manufacturing, and the Elgin Sweeper Company in the Southwestern United States. Sole source letters have been provided by the manufacturers. The Long Beach Water Department has four (4) CCTV vehicles equipped with Envirosight camera systems, five (5) Vactor cleaning trucks, and one (1) Elgin sweeper in its current fleet. To keep these vehicles and equipment maintained properly, and for their warranties to remain valid, replacement parts and service must be purchased from Haaker Equipment Company, the authorized distributor in this region.

Staff Recommendation:

Adopt Resolution No. WD-1420 authorizing the General Manager to enter into a sole source contract with Haaker Equipment Company for manufacturer authorized replacement parts and services, in an amount not to exceed \$150,000 for a one-year period and to exercise the option to renew for two (2) additional one-year periods.

Fiscal Impact: The cost to the Water and Sewer Fund will be incurred during FY 20 and FY 21 with the actual annual amounts unknown at this time but the total amount will not exceed the contract total of \$150,000. These costs are included in the Water and Sewer Fund FY 20 Budget and financial projections.

A RESOLUTION OF THE BOARD OF WATER COMMISSIONERS OF THE CITY OF LONG BEACH AUTHORIZING THE GENERAL MANAGER TO EXECUTE A CONTRACT WITH HAAKER EQUIPMENT COMPANY, WITHOUT ADVERTISING FOR BIDS, TO PROVIDE ASNEEDED MANUFACTURER AUTHORIZED REPLACEMENT PARTS AND SERVICES IN AN AMOUNT NOT TO EXCEED \$150,000

WHEREAS, the Long Beach Water Department ("LBWD") has four (4) CCTV vehicles equipped with Envirosight camera systems, five (5) Vactor cleaning trucks, and one (1) Elgin sweeper in its current fleet; and

WHEREAS, to keep these vehicles maintained properly and for their warranties to remain valid, replacement parts and services must be purchased from an authorized distributor; and

WHEREAS, Haaker Equipment Company is the sole distributor of Envirosight camera systems, Vactor Manufacturing, and the Elgin Sweeper Company in the Southwestern United States; and

WHEREAS, as a result, no useful purpose would be served by advertising for bids and to do so would constitute an idle and useless act and an unnecessary expenditure of public funds;

NOW, THEREFORE, the Board of Water Commissioners of the City of Long Beach resolves as follows:

Section 1. That the above recitals are true and correct and are incorporated herein.

Section 2. The General Manager of the Long Beach Water Department is

Section 3. This Resolution shall take effect immediately on its adoption by the Board, and the Secretary of the Board shall certify to the vote adopting this Resolution.
