RECOMMENDATION:

Adopt a Resolution approving an exception to the 180-day waiting period for Public Agencies pursuant to Government Code 7522.56 and 21224, to hire Arthur Cox for a limited duration to work in the Public Works Department. (Citywide)

DISCUSSION

On January 1, 2013, the Public Employees' Pension Reform Act added Sections 7522.56 and 21224 to the Government Code, which set forth post-retirement employment requirements applicable to all retirees who are employed by CaIPERS employers on or after January 1, 2013. This change added the requirement that all retirees must wait 180 days after their retirement date before they are eligible to begin post-retirement employment with a CaIPERS agency. An exception to the 180-day wait period can be made if a public agency certifies the nature of the employment and that the appointment is necessary to fill a critically needed position before 180 days have passed. The appointment must be approved by the governing body of the employer in a public meeting and may not be placed on a consent calendar.

The Public Works Department is requesting City Council approval to hire Arthur Cox effective February 11, 2020, who retired as the Public Service Bureau Manager on December 30, 2019, for a limited duration, to assist with the facilitation of disaster preparedness response and special events during the transition to a new bureau manager. Since Mr. Cox's proposed start date is less than the required 180-day waiting period post retirement, City Council approval to hire Mr. Cox is required. The proposed rate of pay will be \$55.000 per hour, which represents the compensation for the Special Projects Officer and will be funded through the Department of Public Works budget.

Mr. Cox was with the City for 36 years, with the last 15 years in the Public Service Bureau, and has gained valuable institutional knowledge that will serve as an asset to the Public Works Department during the transition to a new bureau manager. Mr. Cox is a subject-matter expert in disaster response and special events support.

This matter was reviewed by Principal Deputy City Attorney Gary J. Anderson on January 21, 2020 and by Budget Analysis Officer Julissa José-Murray on January 24, 2020.

TIMING CONSIDERATIONS

City Council action is requested on February 11, 2020, to ensure minimal impact to disaster response and special events support.

FISCAL IMPACT

The total annual cost through June 30, 2020 will not exceed \$19,800 (360 hours at \$55.000/hour). There is sufficient appropriation budgeted in the General Fund Group in the Public Works Department. This recommendation has no staffing impact beyond the normal budgeted scope of duties and is consistent with existing City Council priorities. There is no local job impact associated with this recommendation.

Approve recommendation.

4 WHEREAS, the compensation paid to retirees cannot be less than the 5 minimum nor exceed the maximum monthly base salary paid to other employees 6 performing comparable duties, divided by 173.333 to equal the hourly rate; and

7 WHEREAS, the maximum base salary for this position is \$115,000 monthly 8 and the hourly equivalent is \$55.099, and the minimum base salary for this position is 9 \$100,000 monthly and the hourly equivalent is \$47.912; and

10 WHEREAS, at the direction of City Council, the hourly rate paid to Arthur 11 Cox as a retired annuitant will be \$55,000; and

12 WHEREAS, Arthur Cox has not and will not receive any other benefit, 13 incentive, compensation in lieu of benefit or other form of compensation in addition to this hourly pay rate;

15 NOW, THEREFORE, the City Council of the City of Long Beach resolves as 16 follows:

17 Section 1. The City Council hereby certifies the nature of the 18 appointment of Arthur Cox as described herein and detailed in the attached appointment letter and that this appointment is necessary to fill the critically needed position of Special 19 20 Projects Officer for the City of Long Beach by February 11, 2020, for the purpose of 21 assisting with disaster response and special event support.

22 Section 2. Arthur Cox is qualified to work on the disaster response and 23 special project support and has acquired the relevant experience and specialized skills 24 from his employment with the City. He has 36 years of service with the City and over 15 25 years as a manager in the Public Service Bureau in the Public Works Department. The 26 effective date of this appointment will be February 11, 2020.

27 Section 3. The compensation for retired annuitant Arthur Cox will be 28 \$55.000 per hour.
