The eastbound lanes of Shoreline Drive between Shoreline 22 Village Drive and the entrance to the Alamitos Beach parking lot from 23 Thursday, May 14, 2020 at 7:00 p.m. to Monday, May 18, 2020 at 10:00 24 a.m. 25 The City Manager is authorized and directed to post notices of Section 3. the intent to temporarily close the streets described in Section 2 above at least twenty-26 27 four (24) hours prior to the closure thereof. 28 Section 4.
