EXAMPLES OF DUTIES:

Under general supervision, performs journey-level work in the installation, alteration and repair of water, heating and drainage systems in buildings, pump stations, structures and facilities in accordance with the California Plumbing Code of Regulations Title 24 Part 5; lays out work according to job orders, blueprints, specifications, rough sketches and/or from technical experience and judgment; assembles, installs and repairs pipes, fittings and fixtures for water and waste disposal systems and gas, steam, air and water heating systems; connects water and gas heaters, furnaces, appliances and other fixtures; inspects and tests systems for malfunction and determines extent and estimated cost of necessary repairs; replaces or repairs valves and other fixtures; observes safety rules; keeps simple records and makes reports; and performs other related duties as required.

REQUIREMENTS TO FILE: Applicants must meet one of the following options:

- A. Five years (full-time equivalent) of paid experience as a plumber or related experience, one year of which must have been at a journey-level

OR

- B. Five years (5) experience with the City of Long Beach performing plumbing related duties;

OR

- C. A valid State of California Plumbing Contractor's License/C-36 (**proof required**)*

A Los Angeles County Backflow Prevention Device Inspection Certificate and/or a Water Distribution Operator (D-2) Certificate are required for some positions in this classification. Applicants who receive an appointment may be required to attend training for the proper procedures for the handling of asbestos and lead.
